### **REGARDING**

### STIPULATION OF WORK HOURS IN THE MONTH OF RAMADHAN 1441 HIJRAH FOR STATE CIVIL APPARATUS WITHIN GOVERNMENT AGENCIES

For the purpose of carrying out official service duties in the month of Ramadhan 1441 Hijrah, carried out both at the office and at home/residence (work from home) as stipulated in the Minister of Administrative and Bureaucratic Reform Circular Letter Number 19 of 2020 regarding Adjustments to the Work System of State Civil Apparatus for Preventing the Spread of COVID-19 within the Environment of Government Agencies as amended several times, lastly by the Minister

of Administrative and Bureaucratic Reform Circular Letter Number 50 of 2020, it is necessary to adjust the working hours of the State Civil Apparatus as follows:

1. For Government Agencies implementing 5 (six) business days

a.	Monday through Thursday	08.00 - 15.00
	Break	12.00 - 12.30
b.	Friday	08.00 - 15.30
	Break	11.30 - 12.30

2. For Government Agencies implementing 6 (six) business days

a.	Monday through Thursday and Saturday	08.00 - 14.00
	Break	12.00 - 12.30
b.	Friday	08.00 - 14.30
	Break	11.30 - 12.30

- 3. Total effective working hours for Central and Regional Government Agencies implementing 5 (five) or 6 (six) business days during the Month of Ramadhan 1441 Hijrah, a minimum of 32.50 hours per week.
- 4. Every Head of Government Agencies shall determine the decision to implement working hours in Ramadhan 1441 Hijrah and they shall submit the said decision to the Minister of Administrative and Bureaucratic Reform.
- 5. The implementation of service duties of State Civil Apparatus during the period of Public Health Emergency of the Corona Virus Disease 2019 (COVID-19) shall take into account the Minister of Administrative and Bureaucratic Reform Circular Letter Number 38 of 2020 regarding Protocol on the Implementation of Service Duties at Home/Residence (Work From Home) for State Civil Apparatus for Preventing the Spread of COVID-19 within the Environment of Government Agencies.

Thus, this Circular Letter is to be carried out accordingly. Thank you for your attention and cooperation.
