CIRCULAR LETTER NUMBER 5 OF 2020

REGARDING

AMENDMENT OF CIRCULAR LETTER NUMBER 4 OF 2020 REGARDING CRITERIA ON RESTRICTING THE TRAVELING OF PEOPLE FOR THE PURPOSE OF ACCELERATING THE MITIGATION OF THE CORONA VIRUS DISEASE 2019 (COVID-19)

A. Background

With due observance to the continuing need to restrict movement of people for the purpose of accelerating the mitigation of the Corona Virus Disease 2019 (COVID-19), it is necessary to stipulate an amendment to Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19).

B. Objectives and Purposes

The substance of Objectives and Purposes of Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19) remains valid.

C. Scope

The scope of Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19) shall be amended to read as follows:

- 1. Exemptions Criteria
- 2. Exemptions Requirements

D. Legal Basis

The substance of Legal Basis of Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19) remains valid.



E. Amendment to the Exemptions Criteria and Exemptions Requirements

The Exemptions Criteria and Exemptions Requirement in Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19) shall be amended to read as follows:

The criteria for restriction of travelling of people into and/or out from the territory of the state and/or administrative territory with private vehicle or public transportation (land, trains, sea and air) throughout Indonesia;

1. Exemptions Criteria

- a. The traveling of people who work in government or private institution that provides:
 - 1) Acceleration of COVID-19 mitigation services;
 - 2) Defense, security and public order services;
 - 3) Health services;
 - 4) Basic needs services;
 - 5) Basic service support services;
 - 6) Important economic function services.
- b. The traveling of a patient who needs emergency health services and the traveling of people whose core family members (parents, husband/wife, child, birth siblings) are terminally ill or passed away;
- c. The repatriation of Indonesian Migrant Workers (PMI), Indonesian nationals and students/university students who are abroad, and the repatriation of people due to special reasons by the Government to his/her area of origin, in accordance with the prevailing regulations.

2. Exemptions Requirements

- a. The requirements for the traveling of people who work in government or private institution:
 - Present a letter of assignment for State Civil Apparatus, Indonesian National Army (TNI), Indonesian National Police that has been signed by at least echelon 2 Officials;
 - 2) Present a letter of assignment for the employee of State-Owned Enterprises / Regional-Owned Enterprises / non-governmental organization / Business institutions that has been signed by the Board of Directors/Head of Office:



- 3) Present a statement letter of Reserve Transcription Polymerase Chain Reaction (RT-PCR) test with negative result, which is valid for 7 days or a statement letter of Rapid-Test with non-reactive result, which is valid for 3 days at the date of departure;
- 4) Statement letter of absence of symptoms of influenza-like illness issued by a doctor of a Hospital / Community Health Center (*Puskesmas*) for regions that do not have a PCR Test/Rapid Test;
- 5) For those who do not represent a government or private institution, they must prepare a statement letter duly signed and stamped and acknowledged by the Head of the Sub-District/Village:
- 6) Present an identification document (*Kartu Tanda Pengenal* ('KTP') or any other valid identification documents);
- 7) Report the travel plans (departure schedules, itinerary in the area of assignment, as well as return schedule).
- b. The requirements for the traveling of a patient who needs emergency health services and the traveling of people whose core family members (parents, husband/wife, child, birth siblings) are terminally ill or passed away:
 - 1) Present an identification document (KTP or any other valid identification documents);
 - 2) Present a death certificate in accordance with the applicable provisions;
 - 3) Present a reference letter from the Hospital for a patient or person who is terminally ill:
 - 4) Present a statement letter of Reserve Transcription Polymerase Chain Reaction (RT-PCR) test with negative result, which is valid for 7 days or a statement letter of Rapid-Test with non-reactive result, which is valid for 3 days at the date of departure for family members accompanying the patient/person who is terminally ill or deceased; or
 - 5) Statement letter of absence of symptoms of influenza-like illness issued by a doctor of a Hospital / Community Health Center (*Puskesmas*) for regions that do not have a PCR Test/Rapid Test;
- c. The requirements for the repatriation of Indonesian Migrant Workers (PMI, Indonesian nationals and students/university students who are abroad, and repatriation of people due to special reasons by the Government to his/her area of origin:
 - 1) Present an identification document (KTP or any other valid identification documents);
 - 2) Present a statement letter from the Indonesian Migrant Workers Protection Agency (BP2MI) or a statement letter from the



- Representative Office of the Republic of Indonesia abroad for Indonesian Migrant Workers;
- 3) Present a statement letter from the University or School for students/university students;
- 4) Present a statement letter of Reserve Transcription Polymerase Chain Reaction (RT-PCR) test with negative result, which is valid for 7 days or a statement letter of Rapid-Test with non-reactive result, which is valid for 3 days at the date of departure;
- 5) Fulfill the requirements in accordance with the applicable provisions regarding repatriation of Indonesian Migrant Workers (PMI), Indonesian nationals, and students/university students who are abroad, as well as repatriation of people due to special reasons by the Government.

F. Control, Supervision and Law Enforcement

The substance of Control, Supervision and Law Enforcement Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19) remains valid.

G. Amendment of Validity Period

The provisions of validity period of Circular Letter Number 4 of 2020 regarding Criteria on Restricting the Traveling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19) shall be amended to read as follows:

This Circular Letter shall come into force as of the date of its stipulation, until June 7, 2020.

H. Closing

Thus this Circular Letter is formulated to be implemented in a well and responsible manner.
