#### CIRCULAR LETTER NUMBER: SE.9/AJ.201/DRJD/2020

### REGARDING

### ARRANGEMENT ON ENFORCEMENT OF THE PROHIBITION OF LAND TRANSPORTATION DURING THE 1441 HIJRIAH EID AL-FITR HOMECOMING (*MUDIK*) PERIOD FOR THE PURPOSE OF MITIGATING THE SPREAD OF THE CORONA VIRUS DISEASE 2019 (COVID-19)

- 1. For the purpose of the enforcement of the operation of land transportation that may operate during the temporary prohibition period on the usage of land transportation in the homecoming (*mudik*) period for Eid Al-Fitr Hijri Year 1441, a limitation criteria has been stipulated for the travel of people to mitigate the spread of Corona Virus Disease 2019 (COVID-19) by the Task Force for the Acceleration of COVID-19 Mitigation.
- 2. Legal Basis:
  - a. Law Number 17 of 2018 regarding Shipping;
  - b. Law Number 22 of 2009 regarding Traffic and Road Transport;
  - c. Law Number 6 of 2018 regarding Health Quarantine;
  - Government Regulation Number 21 of 2020 regarding Limitation on Large-Scale Social Restrictions in order to Accelerate the Mitigation of Corona Virus Disease 2019 (COVID-19);
  - e. Presidential Decree Number 11 of 2020 regarding the Stipulation of the Corona Virus Disease 2019 (COVID-19) Public Health Emergency;
  - f. Minister of Health of the Republic of Indonesia Regulation Number 9 of 2020 regarding the Guidelines for Large-Scale Social Restrictions to Accelerate Mitigation of the Corona Virus Disease 2019 (COVID-19);

- g. Minister of Transportation of the Republic of Indonesia Regulation Number PM 18 of 2020 regarding Transportation Control for the Purpose of Preventing the Spread of Corona Virus Disease 2019 (COVID-19);
- Minister of Transportation Regulation of the Republic of Indonesia Number PM 25 of 2020 regarding Transportation Control during the 1441 Hijriaj Eid Al-Fitr Homecoming (*Mudik*) Period for the Purpose of Preventing the Spread of Corona Virus Disease 2019 (COVID-19);

- 3. In light of the stipulation of Circular Letter of the Head of Task Force for the Acceleration of COVID-19 Mitigation as referred to in point 1 (one), by this Circular Letter a directive is undertaken for land transport that may operate during the temporary prohibition period of the usage of land transportation on the homecoming (*mudik*) period of 1441 Eid Hijriah Al-Fitri with the following terms:
  - a. Head of the Land Transportation Management Office
    - Conduct monitoring and ensure the implementation of the Circular Letter of the Task Force as referred to herein and in its implementation coordinate with relevant stakeholders, Police of the Republic of Indonesia, Indonesian National Armed Forces, Regional Government, Regional COVID-19 Task Force, and other relevant Institutions;
    - Coordinate with Regional COVID-19 Task Force in forming security and examination posts in every passenger terminal and crossing port that is equipped with health protocol operating facilities;
    - 3) Ensure that the Passenger Terminal and Crossing Port maintain its 24 (twenty four) hour operations whilst observing the health protocol;

- Ensure that every prospective passenger or user of the service to be obliged to wear masks within the area of the passenger terminal and crossing port;
- 5) Ensure that Public Transport Companies and Crossing Port Operators implements the terms in the Circular Letter of the Task Force as referred to herein; and
- 6) Report the monitoring results to the Director General of Land Transportation.
- b. Head of the DKI Jakarta Province Transportation Board
  - Conduct monitoring and ensure the implementation of the Circular Letter of the Task Force as referred to herein and in its implementation coordinate with relevant stakeholders, Indonesian National Police, Indonesian National Army (TNI), Regional Government, Regional COVID-119 Task Force, and other relevant Institutions;
  - 2) Coordinate with Regional COVID-19 Task Force in forming security and examination posts in every passenger terminal that is equipped with health protocol operating facilities;
  - 3) Ensure that the Passenger Terminal maintain its 24 (twenty four) hour operations whilst observing the health protocol;
  - Ensure that every prospective passenger or user of the service to be obliged to wear masks within the area of the passenger terminal and crossing port;
  - 5) Ensure that Public Transport Companies implements the terms in the Circular Letter of the Task Force as referred to herein; and
  - 6) Report the monitoring results to the Director General of Land Transportation and copied to Head of the Jabodetabek Transportation Management Body.
- c. Public Transport Company
  - 1) Implement and observe the terms in the Circular Letter of the Chairperson of Task Force for the Acceleration of COVID-19 Mitigation

Number 4 of 2020 regarding Criteria on Restricting the Travelling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19);

- Ticket reservations may only be conducted through the Main Office or Branch Office of Public Transport Operators, with Return Tickets (PP) unless with differing continued destination.
- Ensure that prospective passengers fulfill the requirements in the Circular Letter of the Task Force as referred to herein prior to the issuance of a ticket or travel document;
- 4) Ensure that the crew of public motor vehicles that are on duty fulfill the following terms:
  - a) possess a COVID-19 negative statement letter from institutions/work units responsible in the field of health or Task Force for Accelerating of COVID-19 Mitigation for the maximum period of 14 (fourteen days) after the test results are issued;
  - b) use masks and gloves while on duty;
- 5) Ensure that Passengers are obliged to wear masks throughout the travel;
- 6) Public motorized vehicles that are permitted to operate are equipped with special signage as provided in the Appendix which forms an inseparable part of this Circular Letter of the Director General;
- 7) Transport of People through Motorized Public Vehicles during the Corona Virus Disease 2019 (COVID-19) emergency period may carry goods for the types of services as provided in the Circular Letter of the Task Force with a time limit of 3 (three) months;
- Must implement and fulfill Minister of Transportation of the Republic of Indonesia Regulation Number PM 18 of 2020 regarding Transportation Control for the Purpose of Preventing the Spread of Corona Virus Disease 2019 (COVID-19);
- 9) Fulfill the health protocol to prevent the spread of COVID-19 that is stipulated by the relevant institution.



- d. Crossing Port Operator
  - Implement and comply with the terms of the Circular Letter of the Head of Task Force for the Acceleration of COVID-19 Mitigation Number 4 of 2020 regarding Criteria on Restricting the Travelling of People for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019 (COVID-19);
  - 2) Online ticket services are only applicable to freight vehicles, logistic carrying vehicles, and freight vehicles carrying medicine and health equipment which utilizes crossing transportation means;
  - Public Motorized Vehicles who are permitted to utilize crossing transportation shall obtain approval from police force officers at the last checkpoint;
  - For service users that are permitted to utilize crossing transportation as provided in number 3), tickets are purchased through special gates at the local crossing port;
  - 5) Crossing Port Manager shall provide special toll gates as provided in number 4).
  - 6) Must ensure that the prospective service users fulfill the requirements of the Circular Letter of the Task Force as referred to herein prior to the issuance of the ticket or travel document;
  - 7) Ensure that Passengers use masks during the trip; and
  - Ensure the implementation and fulfillment of Minister of Transportation of the Republic of Indonesia Regulation Number PM 18 of 2020 regarding Transportation Control for the Purpose of Preventing the Spread of Corona Virus Disease 2019 (COVID-19).
- 4. This Circular Letter is effective since the date of May 8, 2020 until May 31, 2020 and may be extended in accordance with needs.
- 5. Thus this Circular Letter is to be implemented with full responsibility.
