NUMBER 18 OF 2020

REGARDING

GUIDELINES FOR LARGE-SCALE SOCIAL RESTRICTIONS IN THE MITIGATION OF THE CORONA VIRUS DISEASE 2019 (COVID-19) IN EAST JAVA PROVINCE

WITH THE GRACE OF GOD ALMIGHTY

THE GOVERNOR OF EAST JAVA,

- Considering : a. whereas in the effort to accelerate the mitigation of the Corona Virus Disease 2019 (COVID-19) in the Region of East Java, it is necessary to implement Large-Scale Social Restrictions in several Regency/City regions in East Java Province as stipulated by the Minister of Health;
 - whereas the Large-Scale Social Restrictions (PSBB) as referred to in consideration letter a, is necessary to suppress the massive spread of the COVID-19 through restrictions on certain activities which in its implementation requires guidelines for the parties of interest;
 - whereas based on the considerations as referred to in letter a and letter b, it is necessary to stipulate a Regulation of the Governor regarding Guidelines on Large-Scale Social Restrictions in the Mitigation of the Corona Virus Disease 2019 (COVID-19) in East Java Province;

HAS DECIDED:

To Stipulate : REGULATION OF THE GOVERNOR REGARDING GUIDELINES FOR LARGE-SCALE SOCIAL RESTRICTIONS IN THE MITIGATION OF THE CORONA VIRUS DISEASE 2019 (COVID-19) IN EAST JAVA PROVINCE.

CHAPTER I

GENERAL PROVISIONS

Article 1

In this Governor Regulation, what is meant by:

- 1. Province is East Java Province.
- 2. Provincial Government is Provincial Regional Government.

- 3. Governor is the Governor of East Java.
- 4. Large-Scale Social Restrictions (*Pembatasan Sosial Berskala Besar*) hereinafter abbreviated as PSBB are restrictions on certain activities of residents in an area



suspected of being infected with the Corona Virus Disease 2019 (COVID-19) in such a way as to prevent the possible spread of the Corona Virus Disease 2019 (COVID-19).

- 5. Regency/City Government is the Regency/City Regional Government in the Province that implements PSBB.
- 6. Regent/Mayor is the Regent/Mayor in the Province that implements PSBB.
- 7. Task Force for the Acceleration of the Corona Virus Disease (COVID-19) Mitigation in the Provincial level, hereinafter referred to as the Provincial Level Task Force, is the team formed by the Government, whose duties are to accelerate the mitigation of the COVID-19 through synergy between governments, business entities, academics, society, and media.
- Task Force for the Acceleration of the Corona Virus Disease (COVID-19) Mitigation in the Regency/City level, hereinafter referred to as the Regency/City Level Task Force, is the Task Force for the Acceleration of the Corona Virus Disease 2019 (COVID-19) Mitigation formed by the Regent/Mayor.
- 9. Resident is every person who is domiciled and/or active in the Regency/City.
- 10. Law Enforcer is government and/or regional government institution that carries out law enforcement, among others Indonesian National Police, Attorney of the Republic of Indonesia, Provincial Municipal Police, and Regency/City Municipal Police.

Article 2

This Governor Regulation is intended as a guideline for the implementation of PSBB in the efforts to Accelerate the Mitigation of the Corona Virus Disease 2019 (COVID-19) in the Provincial level.

Article 3

This Governor Regulation aims to regulate:

- a. the restrictions of activities and movement in the community;
- b. the control of case spread and number of new cases;

- c. the reinforcement of control and mitigation efforts; and
- d. the mitigation of social and economic impacts.

Article 4

The scope of this Governor Regulation includes:

- a. implementation;
- b. rights, obligations as well as fulfillment of the resident's basic needs;
- c. resources for the mitigation of the COVID-19;
- d. monitoring, evaluation, and reporting;
- e. funding; and
- f. sanctions.

CHAPTER II

IMPLEMENTATION

Section One

General

Article 5

- (1) In an effort to prevent the widespread of COVID-19, PSBB is implemented in Regency/City.
- (2) PSBB as referred to in paragraph (1) shall be conducted in the form of restrictions on outdoor activities carried out by every person who is domiciled and/or conduct activities in the Regency/City.
- (3) During the implementation of PSBB, every person must:

- a. wash their hands using running water and soap or hand sanitizer, and clean and healthy behavior (*perilaku hidup bersih sehat* or PHBS);
- b. wear face mask and maintain a physical distancing of at least 1 (one) meter in range when in public; and
- c. perform self-isolation either at home and/or isolation room in accordance with the health protocol for:
 - 1. Asymptomatic People (Orang Tanpa Gejala or OTG);
 - 2. People Under Monitoring (Orang Dalam Pemantauan or ODP); or
 - 3. Patients Under Surveillance (*Pasien Dalam Pengawasan* or PDP) with mild symptoms.
- (4) The outdoor activities restrictions in the implementation of PSBB as referred to in paragraph (2) covers:
 - a. implementation of learning in schools and/or other educational institutions;
 - b. implementation of learning in the industry in the context of internships, Field Work Practices and/or other activities;
 - c. work activities in workplace;
 - d. religious activities in houses of worship;
 - e. activities in public places or facilities;
 - f. social and cultural activities; and
 - g. movement of people and goods using modes of transportation.
- (5) Coordination, mobilization of resources and, operational for the implementation of PSBB as referred to in paragraph (1) shall be governed by the Regent/Mayor.
- (6) The stipulation of PSBB as referred to in paragraph (1) shall be stipulated by a Governor Decree.



Section Two

Restriction on the Implementation of Learning in Schools and/or Educational Institutions

Article 6

- (1) During the implementation of PSBB, a suspension of activities shall be carried out in:
 - a. schools;
 - b. other educational institutions; and/or
 - c. industry in the context of internships, Field Work Practices, and/or other activities.
- (2) In the implementation of the suspension of activities in schools as referred to in paragraph (1) letter a, the implementation of all learning activities shall be changed by implementing learning at their respective homes/residences through long distance learning methods and/or virtually/online.
- (3) Activities of school administration services shall be carried out from home with an adjusted form of service.
- (4) The technicalities of implementation and evaluation of learning and school administration services which are the authority of the Provincial Region during the implementation of PSBB shall be further regulated by the Provincial Regional Apparatus that is responsible in the field of education.
- (5) The technicalities of implementation and evaluation of learning and school administration services outside the authority of the Provincial Region during the implementation of PSBB shall be further regulated by the Regent/Mayor.

Article 7

- (1) Other educational institutions that are suspended during the implementation PSBB as referred to in Article 6 paragraph (1) letter b, include:
 - a. higher education institutions

- b. training institutions;
- c. research institutions;
- d. development institutions; and
- e. similar institutions.
- (2) Temporary suspension of activities in other educational institutions as referred to in paragraph (1), shall be excluded for higher education, research, and training institutions related to health services.
- (3) In the implementation of the temporary suspension of activities in other educational institutions as referred to in paragraph (1) and paragraph (2), events, learning activities, and administrative services shall be carried out online from home in accordance with the technical provisions from the relevant agencies.

Article 8

- (1) In the temporary suspension of activities during the implementation of PSBB, the person in charge of the school and other educational institutions must:
 - a. ensure the learning process continues and the rights of students to receive an education are fulfilled;
 - b. conduct the prevention of the spread of COVID-19 in the location and environment of schools and/or other educational institutions; and
 - c. maintain the security of schools and/or other educational institutions.
- (2) Prevention efforts to prevent the spread of the COVID-19 in the location and environment of schools and/or other educational institutions as referred to in paragraph (1) letter b shall be carried out periodically by means of:
 - a. cleaning and disinfecting school facilities and infrastructure; and
 - b. implementing a prevention of the spread of the COVID-19 protocol for educators and other education personnel.



Section Three

Restriction of Work Activities in the Workplace

Article 9

- (1) During the implementation of PSBB, a temporary suspension of work activities shall be carried out in workplace/office.
- (2) During the temporary suspension of work activities in workplace/office as referred to in paragraph (1), the work activities in workplace shall be changed by implementing work activities at their respective homes/residences.
- (3) During the temporary suspension of work activities in workplace/office as referred to in paragraph (1), employees or security must be assigned to look after the workplace/office.

Article 10

- (1) Excluded from temporary suspension of work activities in workplace/office as referred to in Article 9 paragraph (1), are for workplace/office with the following categories:
 - a. all government offices/agencies, both national and regional, including representative offices of other countries based on the arrangements from the relevant ministries;
 - b. state/regional-owned enterprises that participate in the mitigation of the COVID-19 and/or in meeting the basic needs of the community following the arrangements from the relevant ministries, the Provincial Government and/or Regency/City Government;
 - c. business actors engaged in the following sectors:
 - 1. health;
 - 2. foodstuff/food/beverage;
 - 3. energy;
 - 4. communication and information technology;
 - 5. finance;
 - 6. logistics;



- 7. hospitality;
- 8. construction;
- 9. strategic industries;
- 10. basic services, public utilities, and industry stipulated as national vital objects and certain objects; and/or
- 11. daily needs.
- d. local and international community organizations engaged in the disaster and/or social sector.
- (2) In the case of undertaking exceptions to the temporary suspension of work activities in the workplace/office as referred to in paragraph (1), the head of the workplace must conduct:
 - a. restrictions of interactions in work activities;
 - restrictions of every person who has comorbidities and/or conditions that can be fatal if exposed to the COVID-19 to carry out activities in the workplace, among others:
 - 1. sufferers of high blood pressure;
 - 2. people with heart disease;
 - 3. diabetics;
 - 4. sufferers of lung disease;
 - 5. cancer sufferers;
 - 6. pregnant women; and
 - 7. over 60 (sixty) years old.
 - c. implementation of the prevention of the spread of the COVID-19 protocol at work, including:
 - 1. ensuring that the workplace is always clean and hygienic;

- 2. all employees in the office area to wear a face mask and wash their hands regularly using soap and running water or hand sanitizer;
- 3. having operational cooperation in health protection and prevention of the COVID-19 with the nearest health care facility for emergency measures;
- 4. providing vitamins and vitamin-containing nutrients to improve employees' immunity;
- 5. conducting periodical disinfecting of the floor, walls and building equipment of the workplace;



- 6. conduct detecting and monitoring of body temperature of employees entering the workplace and ensuring that no employee working in the workplace have an above normal body temperature or is sick;
- 7. require washing hands with soap and/or hand sanitizers, including providing adequate and easy-to-access hand washing facilities in the workplace;
- 8. maintain a minimum of 1 (one) meter of physical distancing between employees;
- 9. disseminating information as well as advice/recommendation for the prevention of the COVID-19 to be disseminated at strategic locations in the workplace; and
- 10. in the event that an employee in the workplace is found to be a Patient Under Surveillance, then:
 - a) work activities in the workplace must be temporarily suspended for at least 14 (fourteen) business days;
 - b) medical staff assisted by a security unit shall evacuate and spray disinfectants on all work premises, facilities, and equipment; and
 - c) temporary suspension shall be implemented until the process of evacuating and spraying disinfectants, as well as the health examination and isolation of employees who have made physical contacts with employees exposed to the COVID-19 have been completed.
- (3) With respect to the provision of foods and beverages, the person in charge of a restaurant/dining place/similar business has the obligation to:
 - a. restrict their services to only take away, online orders, and/or by phone order or delivery services;
 - b. maintain a minimum of 1 (one) meter physical distancing in queue between customers;
 - c. apply the principle of foodstuff sanitation hygiene in the process of handling food in accordance with the provisions;
 - d. provide supporting devices such as gloves and/or food tongs to minimize direct contact with ready to serve meals in the preparation, processing and serving process;



- e. ensure the adequacy of the heating process in food processing according to standards;
- f. clean work areas, facilities, and equipment, especially those having surface areas directly in contact with food;
- g. provide handwashing facilities for customers and employees;
- h. prohibit employees who are sick or showing an above normal body temperature, cough, runny nose, diarrhea, and shortness of breath to work; and
- i. require employees working directly in food/beverage preparation process to wear gloves, head masks and work attire in accordance with occupational safety and health guidelines.
- (4) With respect to hospitality activities, the person in charge of the hotel must:
 - a. provide special services for guests wishing to conduct independent isolation;
 - b. restrict guests to only activities in hotel rooms by utilizing room service;
 - c. eliminate activities and/or close hotel service facilities that can create crowds in the hotel area;
 - d. prohibit guests who are sick or showing symptoms of respiratory problems, being an above normal body temperature, cough, runny nose, diarrhea and shortness of breath to enter the hotel;
 - e. require employees to wear masks, gloves, and work attire in accordance with occupational safety and health guidelines; and
 - f. require hand washing with soap and/or hand sanitizer, as well as providing adequate and accessible hand wash facilities in workplace.
- (5) With respect to construction activities, the owners and/or provider of construction work services have obligations with the following conditions:
 - a. appoint a person in charge for the implementation of the COVID-19 prevention in the project area;
 - b. restrict workers' activities and interactions to be carried out only within the project area; and



- c. provide shelter and daily necessities for all workers during their presence in the project area;
- d. provide health space in the workplace equipped with adequate health facilities;
- e. require workers to wear masks, gloves, and work attire in accordance with occupational safety and health guidelines;
- f. require hand washing with soap and/or hand sanitizer, as well as providing adequate and easy-to-access hand wash facilities in workplace;
- g. prohibit every person, either workers or other persons, who have an above normal body temperature to be in the work location;
- h. deliver explanations, recommendations, campaigns, promotion of the COVID-19 prevention techniques in every morning occupational health and safety (*Kesehatan dan Keselamatan Kerja*, K3) counseling activity or safety morning talk; and
- i. conduct periodic monitoring of workers' health during their presence in the project area.
- (6) The Regent/Mayor may add workplace/office categories exempted from the temporary suspension of work activities as referred to in paragraph (1), and regulate the technicalities thereof, in accordance with the laws and regulations and the regional necessities.

Section Four

Restrictions on Religious Activities in Houses of Worship

Article 11

- (1) During the implementation of PSBB, temporary suspension of religious activities in houses of worship and/or in certain place shall be carried.
- (2) During the temporary suspension of religious activities in houses of worship and/or in certain place as referred to in paragraph (1), religious activities shall be carried out in their respective residence.
- (3) Religious mentors/teachers may conduct religious mentoring virtually/online.

(4) During the temporary suspension of religious activities in houses of worship and/or in certain place as referred to in paragraph (1), activities to mark the time of worship

such as call to prayer (*adzan*), bells, and/or other time markers shall be carried out as usual.

Article 12

- (1) During the implementation of the PSBB, the person in charge of the houses of worship must:
 - a. provide education or understanding to their respective worshipers to continue to carry out religious activities at home;
 - b. prevent the spread of the COVID-19 in their respective houses of worship; and
 - c. maintain the security of their respective houses of worship.
- (2) Efforts to prevent the spread of COVID-19 in houses of worship as referred to in paragraph (1) letter b shall be carried out periodically by means of:
 - a. cleaning houses of worship and the surrounding environment;
 - b. disinfecting floors, walls and building equipment in the houses of worship; and
 - c. closing entry access for unauthorized parties.

Section Five

Restrictions of Activities in Public Places or Public Facilities

Article 13

- (1) During the implementation of PSBB, temporary suspension of activities in public places or public facilities is carried out.
- (2) The organizers of public places or public facilities must temporarily close the public places or public facilities for public activities during the implementation of PSBB.
- (3) The following activities are exempted from the prohibition to conduct activities in public place or public facilities as referred to in paragraph (1):
 - a. fulfilling the basic needs and/or daily needs; and
 - b. conducting sports activities independently.



(4) The Regent/Mayor may stipulate additional categories of activities exempted from the prohibition on conducting activities in public places or public facilities as referred to in paragraph (3), and regulate the technicalities thereof, in accordance with the laws and regulations and the regional necessities.

Article 14

- (1) The fulfillment of basic needs as referred to in Article 13 paragraph (3) letter a includes the provision, processing, distribution, and/or delivery of:
 - a. foodstuffs/food/beverage;
 - b. energy;
 - c. communication and information technology;
 - d. financial, banking, and payment system; and/or
 - e. logistics.
- (2) The fulfillment of daily needs as referred to in Article 13 paragraph (3) point a includes:
 - a. provision of retail goods in:
 - 1. community/traditional market;
 - 2. self-service stores, in the type of minimarkets, supermarkets, hypermarkets, wholesaler store, and special stores either located in or outside shopping centers; or
 - 3. stores/grocery stores/grocery shops.
 - b. laundry.
- (3) In providing services for the fulfillment of residents' needs during the implementation of PSBB as referred to in paragraphs (1) and (2), business actors shall comply with the provisions on limitation of activities as follows:
 - a. prioritize online and/or remote ordering of goods with delivery services;
 - b. participate in maintaining economic stability and purchasing power of goods consumers by refraining from raising the price of goods;
 - c. conduct periodical disinfection on the business premises;



- d. conduct detection and monitoring of body temperature of the employees and consumers entering the market/store, and ensure that employees on duty are not undergoing sickness or showing symptoms of above normal body temperature, cough, runny nose, diarrhea, and shortness of breath;
- e. require consumers to wear masks;
- f. implement physical distancing between consumers visiting the market/store at least 1 (one) meter;
- g. requiring all employees to wear work attire in accordance with occupational health and safety guidelines; and
- h. implementing the recommendation to wash hands with soap and/or hand sanitizer, including to provide adequate and easy-to-access hand wash facilities for consumers and employees.

Article 15

- (1) Independently conducted sports activities as referred to in Article 13 paragraph (3) letter b may be restrictively carried out by residents outside of their homes during the implementation of PSBB.
- (2) Independently conducted sports activities as referred to in paragraph (1) are carried out under the following conditions:
 - a. they are conducted independently and not conducted in groups; and
 - b. conducted restrictively near the residential area.

Section Six

Restrictions on Social and Cultural Activities

Article 16

- (1) During the implementation of the PSBB, suspension of social and cultural activities causing crowds of people is implemented.
- (2) Social and cultural activities as referred to in paragraph (1) also includes activities relating to gathering or meeting on:
 - a. politics;



- b. sports;
- c. entertainment;
- d. academic; and
- e. culture.

Article 17

- (1) The following activities are exempted from the suspension of social and cultural activities as referred to in Article 16 paragraph (1):
 - a. circumcision (*khitan*);
 - b. wedding; and
 - c. burial and/or funeral (*takziah*) of persons passing away due to causes other than COVID-19.
- (2) *Khitan* as referred to in paragraph (1) letter a is carried out under the following conditions:
 - a. conducted in medical services facilities;
 - b. attended by limited number of people, which are the immediate family members;
 - c. wearing masks;
 - d. exclusion of ceremonies that gather crowds; and
 - e. maintain a minimum of 1 (one) meter of physical distancing between the attendees.
- (3) Weddings as referred to in paragraph (1) letter b is carried out under the following conditions:
 - a. conducted in Religious Affairs Office and/or Civil Registration Office;
 - b. attended by limited number of people, which are the immediate family members;
 - c. wearing masks;
 - d. exclusion of wedding ceremonies or receptions that invite and gather crowds; and



- e. maintain a minimum of 1 (one) meter of physical distancing between the attendees; and
- (4) The burial and/or funeral of persons passing away due to causes other than the COVID-19 as referred to in paragraph (1) letter c is carried out under the following conditions:
 - a. conducted in funeral homes;
 - b. attended by limited number of people, which are the direct family members;
 - c. wearing masks; and
 - d. maintain a minimum of 1 (one) meter of physical distancing between the attendees.
- (5) The Regent/Mayor may add additional categories of activities that are exempted from the suspension of social and cultural activities as referred to in paragraph (1), and regulate the technicalities thereof, in accordance with the laws and regulations and the regional necessities.

Section Seven

Restriction on the Use of Transportation Modes for the Movement of People and Goods

Article 18

- (1) During the implementation of PSBB, all movement of people and/or goods are temporarily suspended, except for the purpose of:
 - a. fulfillment of basic needs;
 - b. other activities specifically in relation to defense and security aspects; and
 - c. activities that are permitted during the implementation of PSBB.
- (2) The following transportation modes are exempted from the suspension of movement of people as referred to in paragraph (1):
 - a. personal motor vehicle;
 - b. public passenger transportation with motor vehicle;

c. train transportation; and



- d. river transportation, lake transportation, and transportation for crossing.
- (3) All modes of transportation are exempted from the suspension of movement of goods as referred to in paragraph (1).
- (4) Users of personal passenger cars are obliged to comply with the following provisions:
 - a. such cars are only used to fulfill basic needs and/or other activities that are permitted during the implementation of PSBB;
 - b. conduct disinfection of the vehicles after their use;
 - c. wear a mask inside the vehicle;
 - d. limit the number of persons at a maximum of 50% (fifty percent) from the vehicle capacity; and
 - e. refrain from driving if the body temperature reaches above normal temperature, experiencing cough, runny nose, diarrhea, and shortness of breath.
- (5) Users of personal motorcycles are obliged to comply with the following provisions:
 - a. such personal motorcycle is only used to fulfill basic needs and/or other activities permitted during the implementation of PSBB;
 - b. conduct disinfection of vehicles and attributes after being used;
 - c. wearing mask and gloves;
 - d. refrain from driving if the body temperature reaches above normal temperature, coughs, runny nose, diarrhea and shortness of breath; and
 - e. refraining from transporting passengers/riding in tandem during the enforcement of operational hours and/or restrictions in certain areas.
- (6) The use of application-based two-wheel transportation services is restricted to only the transportation of goods.
- (7) Passenger transportation with public motor transportation, train transportation, and/or goods transportation are required to follow the following provisions:

a. limiting the number of persons at a maximum of 50% (fifty percent) of the vehicle's capacity;



- b. for vehicles with seats:
 - 1. one line carried at most 2 (two) people; and
 - 2. two lines carried at most 3 (three) people.
- c. limiting operational hours and/or certain areas according to the regulations of the Provincial Government and/or related agency motorized vehicles with routes and rail transportation, operating hours are limited from 05.00 WIB until 19.00 WIB on time and with frequency as needed;
- d. periodically disinfecting the mode of transportation used;
- e. wearing mask and gloves;
- f. detecting and observing the body temperature of officials and passengers entering modes of transportation;
- g. ensuring that officials and passengers of modes of transportation are not experiencing body temperature above normal or sick; and
- h. maintaining physical distancing both during queuing up and inside the vehicle.
- (8) River, lake, and ferry transport may carry passengers with the following provisions:
 - a. limiting the number of persons at a maximum of 50% (fifty percent) of the vehicle's capacity;
 - b. maintaining physical distancing both during queuing up and inside the vehicle.
 - c. apply port operating time adjusted to the ship's operating schedule.
- (9) Regents/Mayors may add to the transportation modes exempted from temporary suspension of modes of transportation for the transportation of persons and/or goods as referred to in paragraph (2) and paragraph (3) as well as regulating it technically, in accordance with the provisions of laws and regulations.
- (10) The implementation of restrictions on the use of transportation modes for people and goods as referred to in paragraph (1) shall be carried out in accordance with technical guidelines set by the Regent/Mayor.



CHAPTER III CERTAIN ACTIVITIES THAT ARE STILL CARRIED OUT

Article 19

Certain activities that are still carried out during PSBB covers:

- a. health services facilities;
- b. other activities related to defense and security aspects; and
- c. central, Province and Regency/City task force activities

CHAPTER IV RIGHTS AND OBLIGATIONS AND THE FULFILLMENT OF THE BASIC NEEDS OF THE RESIDENTS

Section One

Rights and Obligations

Article 20

- (1) During the implementation of PSBB, all residents in the Regency/City has equal rights to:
 - a. receive treatment and services from the Provincial Regional Government and the Regency/City Regional Government;
 - b. receive primary health services according to their medical needs;
 - c. obtain public data and information in relation to the COVID-19;
 - d. ease of access to public complaint services in relation to the COVID-19; and
 - e. care services for the deceased and burial services for persons passing away due to and/or suspected of the COVID-19.



(2) The implementation of the fulfillment of rights as referred to in paragraph (1) follows the technical guidelines determined by the Regent/Mayor.

Article 21

- (1) During the implementation of PSBB, all Residents in the Regency/City shall:
 - a. comply with all provisions on the implementation of PSBB;
 - b. participate in the implementation of PSBB; and
 - c. implement clean and healthy behavior (PHBS).
- (2) In the mitigating of COVID-19, every resident shall:
 - a. participate in the testing and sampling for the COVID-19 in the epidemiology examination (contact tracing) if the officer has instructed such examination;
 - b. conduct self-isolation in the place of residence and/or shelter or in the hospital based on medical workers' recommendation; and
 - c. report to medical workers and/or officials in the event of exposure to the COVID-19 of themselves, family and/or the community.
- (3) Carrying out their obligations as referred to in paragraph (2) must comply with the technical instructions stipulated by the Regent/Mayor.

Section Two

Fulfillment of the Basic Needs of the Resident

Article 22

- (1) The Provincial Regional Government and the Regency/City Regional Government may provide financial/ basic non-financial aid to residents affected in fulfilling their basic needs during the implementation of PSBB.
- (2) The financial/ basic non-financial aids as referred to in paragraph (1) are provided in the form of essential needs and/or other direct aid of which distribution mechanism shall be in accordance with the provisions of laws and regulations.



(3) The stipulation of the eligible receiver of financial/basic non-financial aids as referred to in paragraph (2) is stipulated in accordance with the provisions of laws and regulations.

Article 23

- (1) The Provincial Regional Government and the Regency/City Regional Government may provide incentives to business actors affected by the implementation of PSBB.
- (2) The incentives as referred to in paragraph (1) are provided in the form of:
 - a. reduction of tax and regional retribution for business actors;
 - b. provision of social aids to employees affected by the implementation of PSBB; and/or
 - c. other aids in accordance with the provisions of laws and regulations.
- (3) The implementation of the provision of incentives as referred to in paragraph (2) shall be carried out in accordance with the provisions of the laws and regulations and taking into account the financial capacities of the Region.

CHAPTER V

RESOURCES FOR THE MITIGATION OF COVID-19

Article 24

- (1) In order to implement the handling and mitigation of COVID-19 the Regency/City, the Regency/City Government shall organize a database and information on the needs of provision and distribution of resources.
- (2) Procedures and the use of information system for the purpose of provision and distribution of resources as referred to in paragraph (1) is stipulated by the Regent/Mayor.



Article 25

- (1) Regency/city governments may conduct institutional collaboration on the implementation of PSBB with other parties in accordance with the provisions of the laws and regulations.
- (2) Institutional collaboration as referred to in paragraph (1) shall be conducted in the form of:
 - a. human resources support;
 - b. facilities and infrastructure;
 - c. data and information;
 - d. services and/or other support.

CHAPTER VI

MONITORING, EVALUATION, AND REPORTING

Article 26

- (1) The monitoring and evaluation of the implementation of PSBB shall be conducted for the purpose of assessing the success of the implementation of PSBB in breaking the transmission chain of the COVID-19.
- (2) The monitoring and evaluation as referred to in paragraph (1) shall be conducted by the Regency/City COVID-19 Task Force in accordance with their authorities and duties.
- (3) Assessment of PSBB success as referred to in paragraph (1) is based on the following criteria:
 - a. implementation of PSBB in accordance with this Governor Regulation and Regency/Mayor Regulations;
 - b. number of cases;



- c. number of deaths; and
- d. the spread of cases.

Article 27

- In implementing PSBB, Regency/City Governments, the private sector, academics, the public, and the media actively participate in monitoring the implementation of PSBB.
- (2) The monitoring of PSBB implementation as referred to in paragraph (1) shall be reported public complaint services channel owned by the Regency/City Government and/or the Provincial Government.
- (3) The result of public reports as referred to in paragraph (2) shall be followed up by the Regency/City COVID-19 Task Force in accordance with their authorities and duties.

CHAPTER VII

FUNDING

Article 28

Funding for the implementation of PSBB comes from:

- a. State Revenues and Expenditures Budget;
- b. Provincial Regional Revenues and Expenditures Budget;
- c. Regency/City Regional Revenues and Expenditures Budget; and/or
- d. other legal and non-binding sources in accordance with the provisions of the laws and regulations.



CHAPTER VIII

SANCTIONS

Article 29

- The Provincial Government and/or Regency/City Government applies administrative sanctions to every person and or person in charge of activities that violate the provisions of Article 5 paragraph (3), Article 8 paragraph (1), Article 10 paragraph (2), Article 10 paragraph (3), Article 10 paragraph (4), Article 10 paragraph (5), Article 13 paragraph (2), and/or Article 14 paragraph (3).
- (2) Administrative sanctions as referred to in paragraph (1) takes the form of:
 - a. verbal warning;
 - b. written warning;
 - c. government actions aimed at stopping violations and/or remedies; and/or
 - d. revocation of licenses in accordance with its authority.

Article 30

Every motorist in violation of Article 18 paragraph (4), paragraph (5), paragraph (6), and/or paragraph (7) is subject to administrative sanctions as referred to in Article 29 paragraph (2).

Article 31

In addition to the application of administrative sanctions as referred to in Article 29 paragraph (1) and Article 30, Law Enforcer may exercise their authority in accordance with the provisions of laws and regulations.



CHAPTER IX

CLOSING PROVISIONS

Article 32

Regent/Mayor Regulation as the implementation and technical guidelines of this Governor Regulation shall be stipulated no later than 2 (two) days after the Decree of the Minister of Health regarding the establishment of PSBB in the relevant Regency/City.

Article 33

This Governor Regulation comes into force on the date of enactment.

For public cognizance, this Governor Regulation will be promulgated by placing it in the East Java Province Regional Gazette.
