**THE STIPULATION OF LARGE-SCALE SOCIAL RESTRICTIONS IN TANGERANG  
REGENCY, TANGERANG CITY, AND SOUTH TANGERANG CITY FOR THE PURPOSE OF  
ACCELERATING MITIGATION OF THE CORONA VIRUS DISEASE 2019**

**GOVERNOR OF BANTEN,**

- Considering :
- a. whereas based on the Minister of Health Decree Number HK.01.07/MENKES/249/2020 regarding the Stipulation of Large-Scale Social Restrictions in Tangerang Regency, Tangerang City, and South Tangerang City, Banten Province for the Purpose of Accelerating Mitigation of the Corona Virus Disease 2019 (COVID-19) and to implement the provisions of Article 5 paragraph (6) of Governor of Banten Regulation Number 16 of 2020 regarding the Guidelines of Large-Scale Social Restrictions for the Purpose of Mitigating the Corona Virus Disease 2019 in Tangerang Regency, Tangerang City, and South Tangerang City, it is necessary to stipulate a Governor Decree regarding the Stipulation of Large-Scale Social Restrictions in Tangerang Regency, Tangerang City, and South Tangerang City for the Purpose of Accelerating Mitigation of the Corona Virus Disease 2019;
  - b. whereas based on the considerations as referred to in letter a, it is necessary to stipulate a Governor Decree regarding the Stipulation of Large-Scale Social Restrictions in Tangerang Regency, Tangerang City, and South Tangerang City for the Purpose of Accelerating the Mitigation of the Corona Virus Disease 2019;

  2. Governor of Banten Decree Number 443/Kep.114-Huk/2020 regarding the Stipulation of Unusual Occurrence of Corona (Covid-19) in the Banten Province;
  3. Head of Service Office of Transportation of Banten Province Memorandum Number 550/1250-Dishub.01/2020 regarding Restrictions on the Use of Transportation Modes during PSBB dated April 13, 2020;

HAS DECIDED:

- To Stipulate :
- FIRST : Implement Large-Scale Social Restrictions in Tangerang Regency, Tangerang City, and South Tangerang City for the Purpose of Accelerating Mitigation of the Corona Virus Disease 2019 (COVID-19).
- SECOND : Regional Governments of Tangerang Regency, Tangerang City, and South Tangerang City must implement Large-Scale Social Restrictions as referred to in the FIRST dictum in accordance with the provisions of Laws and Regulations and consistently promote and socialize a hygienic and healthy lifestyle to the community.
- THIRD : Large-Scale Social Restrictions as referred to in the FIRST dictum shall be implemented from April 18, 2020 until May 3, 2020 and may be extended if the transmission of Corona Virus Disease 2019 (COVID-19) remains evident.
- FOURTH : This Governor Decree shall be effective from the date of the stipulation.
