CIRCULAR LETTER

CONCERNING

HEALTH PROTOCOL FOR HANDLING THE RETURN OF INDONESIAN CITIZENS AND ARRIVALS OF FOREIGN CITIZENS FROM ABROAD AT NATIONAL ENTRANCES AND REGIONSIMPLEMENTING LARGE-SCALE SOCIAL RESTRICTIONS (PSBB) TO PREVENT THE SPREAD OF CORONA VIRUS DISEASE 2019 (COVID-19)

In order to accelerate the handling of Corona Virus Disease 2019 (COVID-19), the Government has established a policy to implement Large Scale Social Restrictions (PSBB) as stipulated in Government Regulation Number 21 of 2020 concerning Large Scale Social Restrictions to Accelerate the Mitigation of Corona Virus Disease 2019 (COVID -19) and Regulation of the Minister of Health No. 9 of 2020 concerning Guidelines for Large Scale Social Restrictions to Accelerate the Mitigation of Corona Virus Disease 2019 (COVID -19).

In implementing PSBB in a region, it is necessary to have a guidance in the form of health protocols related to handling the return of Indonesian citizens (WNI) and the arrival of foreign citizens (WNA) from abroad, both at the entrance of the country and in areas that meet the principles of early vigilance and prevention and control efforts and controlling the spread of Coronavirus Disease 2019 (COVID-19). This is because Indonesian citizens from abroad, both Indonesian Migrant Workers (PMI), students, university students, trainees, Ship Crew (ABK), as well as other travelers carrying Indonesian passport, and foreign citizens, still arrive in Indonesia through the entrances of airports/seaports/national land border posts (PLBDN). This can be a threat and health risk factors in the spread of COVID-19. Therefore,

health protocols in handling Indonesian citizens returning and arrivals of foreign citizens from abroad need to be regulated more strictly to control the spread of COVID 19 domestically, which requires good coordinated efforts among relevant stakeholders.

The Health Protocol for Handling the Return of Indonesian Citizens and the Arrival of Foreign Citizens from abroad has been outlined in the Minister of Health Circular Letter Number HK.02.01/MENKES/313/2020 concerning The Health Protocol for Handling the Return of Indonesian Citizens and the Arrivals of Foreign Citizens from abroad at National Entrances and Regions implementing Large-Scale Social Restrictions (PSBB). With the most recent developments, the Circular Letter of the Minister of Health No. HK.02.01 /MENKES/313/2020 needs to be updated so that the implementation of PSBB in the areas can run optimally to be effective in preventing the spread of COVID-19.

This Circular is intended to enhance the support and cooperation among ministries/institutions, regional governments, health service facilities, health workers, and state entrance authorities, in handling travelers, both for the return of Indonesian citizens and the arrival of foreign citizens from abroad at national entrances and in regions implementing PSBB.

concerning Guidelines for the Prevention and Control of Corona Virus Disease 2019 (COVID-19);

In this regard, to prevent and control the importation of COVID-19 cases through increased supervision on Indonesian citizens and foreign citizens entering Indonesia, to all Heads of Ministries/Institutions, Regional Government Leaders, and airport/seaport/national land border posts (PLBDN) authorities, to instruct all levels of their respective units/organizations to implement the Health Protocols for the Handling the Return of Indonesian Citizens and Arrival of Foreign Citizens from Abroad at the National Entrances and in Regions Implementing Large Scale Social Restrictions, as follows:

- The Handling of Return of Indonesian Citizens and Arrival of Foreign Citizens from Abroad at National Entrances and in Regions Implementing Large Scale Social Restrictions, shall be carried out by following applicable health quarantine procedures and additional health screening in Indonesia.
- 2. Handling of Returns of Indonesian Citizens and Arrival of Foreign Citizens from Abroad at the National Entrances:
 - a. To socialize to every citizen and foreigner to apply the principles of prevention and control of COVID-19 by conducting Physical Distancing, always wearing a mask, and applying Clean and Healthy Behavior (PHBS).
 - b. The Port Health Office doctors at the seaport/airport/PLBDN on arrival validate the health certificates carried by citizens and foreigners. Health certificates shall be in English and valid for a maximum of 7 days from being issued by health facilities from the countries of origin.
 - c. For all Indonesian citizens and foreigners:
 - 1) Additional health screening, which includes:
 - a) Interview
 - b) Examination of temperature, signs, and symptoms of COVID-19
 - c) Oxygen Saturation Check
 - d) Rapid Test examination
 - 2) Indonesian Citizens and Foreign Citizens with nonreactive Rapid Test results:
 - a) Given health clearance by health workers in quarantine

facilities.

- b) Bring a Health Alert Card (HAC) that has been given at the entrance.
- c) Can continue the journey to the area of origin or destination by bringing a travel permit from the local COVID Handling Task Force 19, and always applying health protocols, including wearing masks during the journey. Journeys to the area of origin can be facilitated by the government.
- d) Conduct self-quarantine at home for 14 days, implementing physical distancing, wear masks, and Clean and Healthy Behavior (PHBS).
- e) For Indonesian citizens, health clearance is submitted to the local RT/RW which is then forwarded to the local Puskesmas for monitoring during the self-quarantine period at home.
- f) For foreigners, health clearance is submitted to the representatives of their countries to be forwarded to the local regency/city health office for monitoring during the self-quarantine period.
- g) In the event that a foreign national does not have a representative of his/her country in Indonesia or his/her destination does not have a representative office of his/her country, the foreigner reports to the local port health office located at the destination, for further monitoring by the regency/city health office during the self-quarantine period.
- 3) Indonesian citizens and foreign citizens with reactive Rapid Test results, RT-PCR examination is carried out.
 - a) If specimens cannot be taken for RT-PCR examination at the entrance, specimens can be taken for RT-PCR examination upon entry in the quarantine place/facility by health workers, and specimens are sent to laboratories or health facilities that have RT- PCR examination capabilities in the local area.
 - b) If a negative COVID-19 RT-PCR result is found and no disease and/or risk factors are found in the health screening, they can continue their journey to the area of origin or destination by following the provisions in number 2) above.
 - c) If returned positive RT-PCR COVID-19 results:
 - (1) For Indonesian citizens, shall be subject to self-

isolation measures or referral to Emergency Hospitals/Referral Hospitals in the local area based on the patient's health condition at the time of the additional screening, by following the provisions in the Guidelines for the Prevention and Control of Coronavirus Disease 2019 (COVID-19) established by the Minister. Referral is done by applying an infectious disease referral protocol.

- (2) For foreign citizens who have comorbidities or have symptoms of fever and/or one of the symptoms of respiratory disease, they shall be referred to the Emergency Hospital/Referral Hospital in the local area by applying the infectious disease referral protocol.
- (3) For foreigners who do not have comorbidities or do not have symptoms of fever and/or do not have one of the symptoms of respiratory disease, quarantine is conducted at the quarantine place/facility.
- 3. Provisions for Handling the Return of Indonesian Citizens and Arrival of Foreign Citizens from Abroad at the National Entrances in number 2 above apply to the handling of aircraft crews or ship crews both Indonesian citizens and foreign citizens at national entrances.
- 4. For transportation equipment where travelers with reactive Rapid Test results are found or there is preliminary information that there are diseases and/or health risk factors in the transportation equipment, the KKP will conduct disinfection.
- The Handling the Return of Indonesian Citizens and Arrival of Foreign Citizens from Abroad in Regions is carried out in accordance with the Guidelines for Prevention and Control of Coronavirus Disease 2019 (COVID-19) established by the Minister.
- Circular Letter of the Minister of Health Number HK.02.01/MENKES/313/2020 concerning Health Protocol for the Handling of the Returns of Indonesian Citizens and the Arrival of Foreigners from Abroad at National Entrances and in Areas in the Large-Scale Social Restrictions (PSBB) Settings is revoked and declared no longer in force.



Thus this Circular is issued to be carried out with full responsibility and in accordance with the provisions of the legislation.
