**ANNOUNCEMENT OF THE GOVERNOR

**THE HANDLING OF PUBLIC ACTIVITIES IN THE PREVENTION OF COVID-19  
DURING THE CHRISTMAS HOLIDAY PERIOD OF 2020 AND THE 2021  
NEW YEAR**

In the effort of preventing the spread of COVID-19 during the new year holiday period in welcoming the 2020 Christmas Holiday and 2021 New Year Holiday, the Governor of the DKI Jakarta Province calls forth everyone located in the are of the DKI Jakarta Province from December 18, 2020 until January 8, 2021 to increase the activity of preventing the spread of COVID-19, by conducting the following:

1. Prioritize in remaining within their homes and reduce activities outside their homes, unless for basic and/or urgent activities, subject to the following conditions:
  - a. Each person shall wear a mask, keep safe distance and refraining from doing and/or attending activities that may cause a crowd;
  - b. Business actors, managers, administrators or person-in-charge of offices/work places shall implement a limitation of operation hours no later than 19.00 Western Indonesia Time and implement a limitation of capacity of people no more than 50% (fifty percent) of whom works in the offices/work places in one joint period of time, unless it is to implement a public service function and emergencies;
  - c. Business actors, managers, administrators or person-in-charge of shopping centers, malls, food stalls, eating places, cafes, restaurants, movie theatres and tourist location/areas shall implement a limitation of operation hours of no later than 21.00 Western Indonesia Time and implement a limitation of capacity of people no more than 50% (fifty percent) from its total capacity.
2. On the specific dates of December 24, 2020 until December 27, 2020 and December 31, 2020 until January 3, 2021, individuals/families shall reduce activities outside their homes unless it is to conduct activities of prayers, fulfilment of basic needs and/or to urge business actors in implementing a limitation of operational hours no later than 19.00 Western Indonesia Time.

3. Comply with the prevention of COVID-19 protocol along with the enforcement of discipline that is conducted by the Pamong Praja Police Unit (*Satuan Polisi Pamong Praja*) jointly with the relevant Regional Instances and POLRI/TNI officials.

In implementing this Governor Announcement, the Mayor/Regent as Head of the COVID-19 Handling Task Force in the Administrative City/Regency level shall act as the supervisory enforcer.

This Governor Announcement shall be observed and implemented as appropriate.
