#### **REGARDING**

EXTENSION OF THE ENFORCEMENT OF LARGE-SCALE SOCIAL RESTRICTIONS DURING THE TRANSITIONAL PERIOD TO A HEALTHY, SAFE, AND PRODUCTIVE SOCIETY

WITH THE GRACE OF GOD ALMIGHTY

GOVERNOR OF SPECIAL CAPITAL REGION OF JAKARTA,

### Considering

: whereas to implement the provision of Article 4A of Governor Regulation Number 84 of 2020 regarding Amendment of Governor Regulation Number 80 of 2020 regarding Implementation of Large-Scale Social Restrictions during the Transitional Period to a Healthy, Safe, and Productive Society, it is necessary to stipulate Governor Decree regarding the Extension of the Enforcement of Large-Scale Social Restrictions During the Transitional Period to a Healthy, Safe, and Productive Society;

#### HAS DECIDED:

To Stipulate : GOVERNOR DECREE REGARDING EXTENSION OF THE

ENFORCEMENT OF LARGE-SCALE SOCIAL RESTRICTIONS DURING THE TRANSITIONAL PERIOD TO

A HEALTHY, SAFE, AND PRODUCTIVE SOCIETY.

FIRST : To stipulate the extension of the enforcement of Large-Scale

Social Restrictions during the transitional period to a healthy, safe, and productive society for 14 (fourteen) days since

January 4, 2021 until January 17, 2021.

SECOND : In case there is no significant increase of new COVID-19 cases

during the extension of the enforcement of Large-Scale Social Restrictions during the transitional period as referred to in the FIRST dictum, then based on the results of the monitoring and



evaluation by the Provincial level COVID-19 Handling Task Force Unit, to stipulate the extension of the enforcement of Large-Scale Social Restrictions during the transitional period to a healthy, safe, and productive society for 14 (fourteen) days since January 18, 2021 until January 31, 2021.

THIRD : If there is significant increase of new cases based on the

monitoring and evaluation of the Provincial level COVID-19 Handling Task Force Unit, then the enforcement of Large-Scale Social Restrictions during the transitional period as referred to in the FIRST dictum and the SECOND dictum may

be stopped.

FOURTH : This Governor Decree enters into force on January 4, 2021.
