INSTRUCTION OF THE GOVERNOR OF THE SPECIAL CAPITAL REGION OF JAKARTA

NUMBER 39 OF 2021

REGARDING

EXTENSION OF THE IMPLEMENTATION OF MICRO-BASED RESTRICTIONS FOR COMMUNITY ACTIVITIES ON A NEIGHBORHOOD UNIT LEVEL

GOVERNOR OF THE SPECIAL CAPITAL REGION OF JAKARTA.

In order to follow up the Instructions of the Minister of Home Affairs Number 13 of 2021 regarding Extension of Implementation of Micro-Based Restrictions For Community Activities and the Optimizing The Corona Virus Disease 2019 Handling Post At The Village And Sub-District Level For Handling The Spread of The Corona Virus Disease 2019 and Decree of the Governor Number 759 Year 2021 regarding Extension of the Implementation of Micro-Based Restrictions For Community Activities that is conducted since June 15, 2021 until June 28, 2021, hereby instruct: :

- To 1. Assistant for Governance of the Regional Secretary of DKI Jakarta Province
 - 2. Task Executor (Plt.) of Assistant for People's Welfare of the Regional Secretary of DKI Jakarta Province
 - 3. Plt. of Chief Executive of the Regional Disaster Management Agency of DKI Jakarta Province
 - 4. All Mayors of DKI Jakarta Province
 - 5. Regent of Kepulauan Seribu of DKI Jakarta Province
 - 6. The Head of Health Service Office of DKI Jakarta Province
 - 7. The Head of Social Service Office of DKI Jakarta Province
 - 8. The Head of Communication, Informatics and Statistics Service Office of DKI Jakarta Province
 - The Head of Fire Countermeasures and Rescue Service Office of DKI Jakarta Province
 - 10. Plt. of Head of Environment Service Office of DKI Jakarta Province



- 11. The Head of Civil Service Pamong Praja Police Unit of DKI Jakarta Province
- 12. Plt. of Head of Governance Bureau of the Regional Secretariat of DKI Jakarta Province
- 13. The Head of Cooperation Bureau of the Regional Secretariat of DKI Jakarta Province
- 14. The Heads of Districts of DKI Jakarta Province
- 15. The Heads of Sub-Districts of DKI Jakarta Province

To:

FIRST

- The Implementation of Micro-Based Restrictions For Community Activities is conducted by considering the zoning criteria and area control up to the Neighborhood Unit level with the following criteria:
 - a. Green Zone with the criteria that there is no COVID-19 cases in the Neighborhood Unit area therefore the control scenario is conducted with active surveillance, all suspects are tested and case monitoring shall still be carried out regularly and periodically
 - b. Yellow Zone with the criteria that if there is 1 (one) up to two (2) households with confirmed positive cases within one Neighborhood Unit for the previous 7 (seven) days, therefore the control scenario is to find the suspect cases and trace of close contact, then conducting independent isolation for positive patients and close contact under strict surveillance;
 - c. Orange Zone with the criteria that if there are 3 (three) up to 5 (five) households with confirmed positive cases within 1 (one) Neighborhood Unit for the past 7 (seven) days, therefore the control scenario is to find suspect cases and close contact tracing, then conducting self-isolation for positive patients and close contact under strict surveillance, as well as closing houses of worship, children's playground, and other public places except for essential sectors; and
 - d. Red Zone with the criteria if there are more than 5 (five) households with confirmed positive cases within 1 (one)



Neighborhood Unit for the past 7 (seven) days with the control scenario includes:

- 1. finding suspect cases and close contact tracing;
- 2. conducting independent/centered isolation with strict surveillance;
- 3. restricting houses of worship with strict health protocol,
- 4. closing children's playground, and other public places except for essential sectors;
- 5. prohibiting crowds of more than 3 (three) people;
- 6. limiting entry and exit to the Neighborhood Unit area until a maximum of 20.00 WIB; and
- 7. eliminating social community activities in the Neighborhood Unit premises that create crowds and have the potential to cause transmission.

SECOND

: To provide support to the Implementation of Micro-Based Restrictions For Community Activities on Neighborhood Unit level and by involving all stakeholders, with each of the following tasks:

- a. Assistant for Governance of the Regional Secretary shall coordinate the Implementation of Micro-Based Restrictions For Community Activities by Mayor/Regent and/or the relevant Regional Apparatus in accordance with its authorities.
- b. Plt. of Assistant for People's Welfare of the Regional Secretary shall coordinate the Implementation of Micro-Based Restrictions For Community Activities by Mayor/Regent and/or the relevant Regional Apparatus in accordance with its authorities.
- c. Plt. of Chief Executive of the Regional Disaster Management Agency shall:
 - conduct the monitoring of the Implementation of Micro-Based Restrictions For Community Activities;
 - 2. coordinate the provision of support from the Regional Apparatus and/or other instances in fulfilling needs during the validity of the Implementation of Micro-Based Restrictions For Community Activities;



- provide support in the fulfillment of needs during the Implementation of Micro-Based Restrictions For Community Activities; and
- 4. draw up a Governor report to the Ministry of Home Affairs on the result of the Implementation of Micro-Based Restrictions For Community Activities.

d. The Mayors/Regents shall:

- coordinate the Implementation of Micro-Based Restrictions
 For Community Activities by the Covid-19 Handling Task
 Force of City/Regency level in accordance with its
 authorities;
- 2. Mayor/Regent as the Chief of City/Regency Task Force shall stipulate the city/regency area zone based on the criteria which has been stipulated in the Instructions of the Ministry of Home Affairs Number 13 of 2021 regarding Extension of Implementation of Micro-Based Restrictions For Community Activities and the Optimizing The Corona Virus Disease 2019 Handling Post At The Village And Sub-District Level For Handling The Spread of The Corona Virus Disease 2019.
- coordinate the Heads of District and Sub-District in accordance with its authorities to implement the Implementation of Micro-Based Restrictions For Community Activities based on the Covid-19 data case from the Health Service Office:
- to conduct coordination with the relevant instances in the fulfilment of needs during the Implementation of Micro-Based Restrictions For Community Activities; and
- 5. to stipulate the establishment of the Covid-19 Task Force Handling Post of City/Regency level.

e. Head of Health Service Office

- 1. to convey the data of citizens of each Districts confirmed with Covid-19 to the Mayor/Regent;
- accommodate health services through testing, tracing, and treatment activities on confirmed citizens with Covid-19 in the Implementation of Micro-Based Restrictions For Community Activities; and



- coordinate the implementation of health services activities in the Implementation of Micro-Based Restrictions For Community Activities in the Province of DKI Jakarta.
- f. Head of Social Service Office shall provide provision of needs support in the form of food and psychosocial for citizens in selfisolation and families in one household on the location of the Implementation of Micro-Based Restrictions For Community Activities.
- g. The Head of Communication, Informatics and Statistics Service Office shall:
 - prepare the materials for information dissemination regarding the Implementation of Micro-Based Restrictions For Community Activities; and
 - conduct monitoring and evaluation in the process of presentation and publication of the Implementation of Micro-Based Restrictions For Community Activities.
- h. The Head of Fire and Rescue Service Office shall:
 - disinfect and sterilize the location of Implementation of Micro-Based Restrictions For Community Activities; and
 - 2. support the service activities on the location of the Implementation of Micro-Based Restrictions For Community Activities in accordance with the scope of its task.
- i. Plt. Head of Environment Service Office shall:
 - transport medical waste and household waste of citizens confirmed with Covid-19 during the Implementation of Micro-Based Restrictions For Community Activities;
 - to accommodate the management of medical waste on the location of the Implementation of Micro-Based Restrictions For Community Activities; and
 - 3. support the service activities on the location of the Implementation of Micro-Based Restrictions For Community Activities in accordance with the scope of its task.
- j. Head of Civil Service Pamong Praja Police Unit:
 - direct and mobilize the personnel of Pamong Praja Police Force of City/Regency, District, Sub-District level to conduct supervision and action against the Implementation of Micro-Based Restrictions For Community Activities;
 - 2. maintain the location security of the Implementation of Micro-Based Restrictions For Community Activities;



- conduct supervision and action of citizens who violates the Covid-19 health protocol during the Implementation of Micro-Based Restrictions For Community Activities;
- strengthening, controlling, supervising the travels of people at check point Posts in each area with the TNI and POLRI on Holidays/National Holidays of 2021; and
- 5. coordinate the imposition of sanctions by the Handling of Covid-19 Task Force of Neighborhood Unit and Community Unit level to citizens who violates the Covid-19 prevention health protocol during the Implementation of Micro-Based Restrictions For Community Activities in accordance with the local culture and the agreements with each local chiefs of Neighborhood Unit and Community Unit.
- k. Plt. of The Head of Governance Bureau of the Regional Secretariat shall:
 - coordinate with the area apparatus in the Implementation of Micro-Based Restrictions For Community Activities in accordance with the scope of its task; and
 - make a report of the Implementation of Micro-Based Restrictions For Community Activities on Neighborhood Unit level.
- I. The Head of Cooperation Bureau of the Regional Secretariat shall prepare support regarding the fulfillment of facilities/infrastructure needs of the Implementation of Micro-Based Restrictions For Community Activities in accordance with the scope of its task.
- m. The Heads of Districts shall:
 - coordinate the Implementation of Micro-Based Restrictions
 For Community Activities on the Work Unit of the related
 Regional Apparatus in the District area;
 - 2. coordinate the Implementation of Micro-Based Restrictions For Community Activities on the Sub-District level;
 - conduct monitoring and evaluation on the Implementation of Micro-Based Restrictions For Community Activities in the Sub-District level;
 - 4. coordinate the organization of quarantine locations of the District level which shall be used in regards of citizens who are confirmed of Covid-19 without proper homes and independent quarantine isolation location with the implementation of strict health protocols and the quarantine



- costs shall be incurred to the community for citizens that are conducting Provincial/City/Regency Travels;
- stipulate the establishment of Covid-19 Handling Task Force 5. post of District level; and
- 6. report the Implementation of Micro-Based Restrictions For Community Activities to the Covid-19 Handling Task Force of City/Regency level.
- n. The Heads of Sub-District shall:
 - stipulate the location of the Implementation of Micro-Based Restrictions For Community Activities based on case data from the Health Service Office with the Decree of the Head of Sub-District as the Chief of Covid-19 Handling Task Force of Sub-District level;
 - 2. conduct supervision on the Implementation of Micro-Based Restrictions For Community Activities of Sub-District area;
 - 3. ensure the Implementation of Micro-Based Restrictions For Community Activities goes well with the scope of its task;
 - 4. stipulate the establishment of the Handling of Covid-19 Task Force Posts of Sub-District level:
 - provide location of self-isolations with the implementation of 5. strict health protocols and its quarantine costs incurred to Community for citizens that conducts Provincial/City/Regency Travels;
 - report the Implementation of Micro-Based Restrictions For 6. Community Activities to the Covid-19 Handling Task Force of District level.

THIRD

: The costs required for the implementation of this Governor Instruction shall be imposed to the Regional Revenue and Expenditure Budget through the Budget Implementation Document of each Regional Apparatus Work Unit and/or other valid and non-binding source.

FOURTH To report the implementation of this Governor Instruction to the Governor

through the Regional Secretariat.
