Following the Letter of the Director of Immigration Traffic Number IMI.2-UM.01.01-2.432 dated September 16, 2021 regarding the Opening and the addition to the requirements for a Limited Stay Visa for the purpose of Working Index C312, we hereby respectfully convey the following:

- 1. Referring to Article 5 of the Minister of Law and Human Rights Regulation Number 34 of 2021, a visa application is submitted by attaching the requirements as stipulated by the laws.
- Article 103 of the Government Regulation No. 48 of 2021 regarding Third Amendment of Government Regulation No. 31 of 2013 regarding the Implementing Regulation of Law No. 6 of 2011 regarding Immigration states that one of the requirements for a limited stay visa application is:
 - a. A statement of good behavior from the competent authority in the Foreigner's country of origin or representatives of the Foreigner's country of origin, and
 - b. A health examination result stating that the Foreigner is free from infectious diseases that endanger public health;
- 3. Based on the facts that occur in the community, there exists difficulties in fulfilling the requirement referred to in point 2 and this can cause obstruction of the inflow of foreigners needed during the national economic recovery period;
- 4. We are of the view that in order to fulfill the requirement as referred to in point 2, an application for a limited stay visa may attach the following documents:
 - a. Statement letter from the sponsors that the foreigner never conducted criminal activity, for the requirement referred to in point 2 letter a, and

b. Evidence that the foreigner has received the complete dosage of COVID-19 vaccine, for the requirement referred to in point 2 letter b.
