To. Please Find Attached Address

Following up on the results of the evaluation of the implementation of international flight handling activities at Soekarno Hatta Airport — Cengkareng, where there has been an increase/addition of health examination facilities in the form of isothermal molecular tests (NAAT/other types) in which results can be known within a maximum of 1 (one) hour including the addition of RT-PCR test equipment by airport operators in collaboration with relevant stakeholders, and taking into account the following:

- that several other international airports have been prepared as entry gates to Indonesia, which are equipped with health inspection facilities as available at Soekarno Hatta Airport; and
- that in order to support the addition of entry gates as referred to in number 1 (one), sufficient and adequate quarantine facilities are already available.

Therefore the provisions regarding the limitation of passenger transportation (inbound traffic) to a maximum of 90 (ninety) people per flight at Soekarno Hatta Airport as stated in the letter of the Director General of Civil Aviation Number:
