TYPES OF ACTIVITIES FOR FOREIGNERS IN THE FRAMEWORK OF GRANTING OF VISA DURING THE PERIOD OF HANDLING THE SPREAD OF THE CORONA VIRUS DISEASE 2019 AND NATIONAL ECONOMIC RECOVERY

MINISTER OF LAW AND HUMAN RIGHTS OF THE REPUBLIC OF INDONESIA,

Considering		:	whereas to implement the provisions in Article 5 paragraph (5) of the Minister of Law and Human Rights Regulation Number 34 of 2021 regarding the Granting of Immigration Visa and Stay Permits During the Period of Handling the Spread of the Corona Virus Disease 2019 and National Economic Recovery, it is necessary to stipulate a Decree of the Minister of Law and Human Rights of the Republic of Indonesia regarding Types of Activities for Foreigners in the Framework of Granting of Visa during the Period of Handling the Spread of the Corona Virus Disease 2019 and National Economic Recovery;

HAS DECIDED:

- To Stipulate : DECREE OF THE MINISTER OF LAW AND HUMAN RIGHTS OF THE REPUBLIC OF INDONESIA REGARDING TYPES OF ACTIVITIES FOR FOREIGNERS IN THE FRAMEWORK OF GRANTING OF VISA DURING THE PERIOD OF HANDLING THE SPREAD OF THE CORONA VIRUS DISEASE 2019 AND NATIONAL ECONOMIC RECOVERY.
- FIRST : Hereby stipulates the list of types of activities for foreigners in the framework of granting of visa during the period of handling of the spread of Corona Virus Disease 2019 and national economic recovery which consists of:
 - 1. Types of activities for Visit Visa;
 - 2. Types of activities for Limited Stay Visa.
- SECOND : The List as referred to in the FIRST Dictum is listed in the attachment and is an inseparable part of this Minister Decree.
- THIRD : This Ministerial Decree comes into force on the date of its promulgation.
