

COVID-19 RESPONSE ACCELERATION TASK FORCE ADDENDUM CIRCULAR LETTER NUMBER 20 YEAR 2021

ABOUT

INTERNATIONAL TRAVEL HEALTH PROTOCOL DURING THE CORONA VIRUS DISEASE PANDEMIC 2019 (COVID-19)

A. Background

- That in order to follow up on the development of the COVID-19 handling situation and the recovery of the national economy, it is necessary to adjust the control mechanism for international travel.
- That based on the considerations as referred to in number 1, it is necessary to stipulate an *Addendum* to Circular Letter Number 20 of 2021 concerning International Travel Health Protocols During the Corona Virus Disease 2019 (COVID-19) Pandemic.

B. Purpose and Objectives

The purpose of this *Addendum* to Circular Letter is to change the provisions for the length of quarantine time and the time for the second RT-PCR test for international travellers during the COVID-19 pandemic. The purpose of this *Addendum* to Circular Letter is to carry out monitoring, control, and evaluation in order to prevent an increase in the transmission of COVID-19.

F. Protocol

Changed some of the conditions with the following sound:

- 3. All International Travelers, both Indonesian Citizens (WNI) and Foreign Citizens (WNA) must comply with the following conditions/requirements:
 - d. Upon arrival, RT-PCR retests are carried out for international travelers and are required to undergo quarantine for 5 x 24 hours for international travelers who have just received the first dose of vaccine or for 3 x 24 hours for international travelers who have received the full dose of vaccine. with the following conditions:
 - 1) For Indonesian citizens, namely Indonesian Migrant Workers (PMI); Student/student; or Government Employees returning from overseas official trips in accordance with the Decree of the Head of The COVID-19 Response Acceleration Task Force No. 14 Year 2021 concerning Entry Points, Quarantine Places, and RT-PCR Obligations for Indonesian Citizens International Traveling at a cost borne by the government.
 - 2) For Indonesian citizens outside the criteria as referred to in number 1) and for foreigners, including foreign diplomats, outside the head of the foreign representative and the family of the head of the foreign representative, they will undergo quarantine in quarantine accommodation.
 - f. In the event that the head of the foreign representative and family serving in Indonesia can self-quarantine at their respective residences for 5 x 24 hours for international travelers who have just received the first dose of vaccine or for 3 x 24 hours for international travelers who have received the vaccine dose complete as referred to in letter d;
 - i. For Indonesian citizens and foreigners, a second RT-PCR test is carried out with the following conditions:
 - 1) On the 4th day of quarantine for international travelers who quarantine with a duration of 5 x 24 hours; or
 - 2) On the 3rd day of quarantine for international travelers who quarantine with a duration of 3 x 24 hours.

G. Monitoring, Control, and Evaluation

H. Closing

This *Addendum* to Circular Letter is effective from November 2, 2021 until a later date and will be evaluated further as needed.
