REVOCATION OF THE MINISTER OF LAW AND HUMAN RIGHTS REGULATION NUMBER 34 OF 2021
REGARDING THE GRANTING OF VISA AND IMMIGRATION STAY PERMIT
DURING THE HANDLING OF THE SPREAD OF CORONA VIRUS DISEASE 2019 AND
NATIONAL ECONOMY RECOVERY

## MINISTER OF LAW AND HUMAN RIGHTS OF THE REPUBLIC OF INDONESIA,

## Considering

- a. whereas to continue on the policy of the Government of the Republic of Indonesia which revoked the implementation of restrictions on community activities resulting from the decline of the Corona Virus Disease 2019, it is necessary to revoke the Minister of Law and Human Rights Regulation Number 34 of 2021 regarding the Granting of Visa and Immigration Stay Permit during the Handling of the Spread of Corona Virus Disease 2019 and National Economy Recovery;
- b. whereas based on the considerations that are referred to in letter a, it is necessary to stipulate the Minister of Law and Human Rights Regulation regarding the Revocation of the Minister of Law and Human Rights Regulation Number 34 of 2021 regarding the Granting of Visa and Immigration Stay Permit during the Handling of the Spread of Corona Virus Disease 2019 and National Economy Recovery;

## HAS DECIDED:

# To stipulate

MINISTER OF LAW AND HUMAN RIGHTS REGULATION REGARDING REVOCATION OF THE MINISTER OF LAW AND HUMAN RIGHTS REGULATION NUMBER 34 OF 2021 REGARDING THE GRANTING OF VISA AND IMMIGRATION STAY PERMIT DURING THE HANDLING OF THE SPREAD OF CORONA VIRUS DISEASE 2019 AND NATIONAL ECONOMY RECOVERY.

## Article 1

Minister of Law and Human Rights Regulation Number 34 of 2021 regarding the Granting of Visa and Immigration Stay Permit during the Handling of the Spread of Corona Virus Disease 2019 and National Economy Recovery (State Gazette of the Republic of Indonesia 2021 Number 1365), revoked and declared invalid.

### Article 2

This Ministerial Regulation shall come into force on the date of promulgation.



For every person to know of it, it is ordered that the promulgation of this Ministerial Regulation is placed in the State Gazette of the Republic of Indonesia.
