**DECREE OF THE HEAD OF THE CAPITAL INVESTMENT COORDINATING BOARD  
NUMBER 185 OF 2020  
REGARDING  
MITIGATION OF THE SPREAD OF COVID-19 FOR EXPERT EXPATRIATE  
WORKERS (TKA) AND HEADS OF COMPANIES FOR THE PURPOSE OF CAPITAL  
INVESTMENT**

**WITH THE GRACE OF GOD ALMIGHTY**

**HEAD OF THE CAPITAL INVESTMENT COORDINATING BOARD**

- Considering :
- a. whereas to carry out the procedure in mitigating the spread of COVID-19 in Indonesia through the entry of Expert Expatriate Workers (TKA) or Heads of Companies, the mitigation of spread of Covid-19 for Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment must be prepared;
  - b. whereas based on the considerations as referred to in letter a, it is necessary to stipulate a Decree of the Head of Capital Investment Coordinating Board regarding Mitigation of the Spread of Covid-19 for Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment;
- Bearing in Mind :
1. Law Number 25 of 2007 regarding Capital Investment (State Gazette of the Republic of Indonesia of 2007 Number 67, Supplement to the State Gazette of the Republic of Indonesia Number 4724);
  2. Government Regulation Number 24 of 2018 regarding Electronically Integrated Business

Licensing Services (State Gazette of the Republic of Indonesia of 2018 Number 90);

3. Presidential Regulation Number 90 of 2007 regarding Capital Investment Coordinating Board as amended several times, lastly by Presidential Regulation Number 24 of 2020 regarding Second Amendment of Presidential Regulation Number 90 of 2007 regarding Capital Investment Coordinating Board (State Gazette of the Republic of Indonesia of 2020 Number 35);
4. Regulation of the Head of Capital Investment Coordinating Board Number 1 of 2020 regarding Implementing Guidelines of Electronically Integrated Business Licensing Services (State Gazette of the Republic of Indonesia of 2020 Number 308)

HAS DECIDED:

- To Stipulate : DECREE OF THE HEAD OF CAPITAL INVESTMENT COORDINATING BOARD REGARDING MITIGATION OF THE SPREAD OF COVID-19 FOR EXPERT EXPATRIATE WORKERS (TKA) AND HEADS OF COMPANIES FOR THE PURPOSE OF CAPITAL INVESTMENT.
- FIRST : Mitigation of the Spread of Covid-19 for Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment as guidelines for foreign expatriates that will enter the Unitary State of the Republic of Indonesia.
- SECOND : Mitigation of the Spread of Covid-19 For Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment shall carry out Swab Tests with Polymerase Chain Reaction (PCR) method.

THIRD : Mitigation of the Spread of Covid-19 for Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment as contained in the Second Dictum shall be carried out as follows:

1. Companies that will bring in Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment shall report the arrival date of the concerned persons to BKPM in accordance with the Supporting Letter for the Utilization of Expert Expatriate Workers (TKA) and/or Heads of Companies;
2. Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment shall carry out Swab Tests with Polymerase Chain Reaction (PCR) method at the Soekarno-Hatta International Airport;
3. While waiting for the test results, Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment shall carry out independent isolation in a Hotel that has been determined by BKPM;
4. Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment with reactive/positive Swab Test results shall carry out isolation/treatment until the test result is negative in the Hotel/Hospital that has been determined by BKPM;
5. Expert Expatriate Workers (TKA) and Heads of Companies for the Purpose of Capital Investment with negative test results can continue their travel to the work location of the company.

FOURTH : This Decree of the Head of Board shall be applicable on the date of its stipulation.
