REGARDING  
STIPULATION OF THE TYPES OF VACCINES FOR THE IMPLEMENTATION OF THE  
CORONA VIRUS DISEASE 2019 (COVID-19) VACCINATION

WITH THE GRACE OF GOD ALMIGHTY

MINISTER OF HEALTH OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. whereas in the context of implementing the Corona Virus Disease 2019 (COVID-19) vaccination in Indonesia, the Minister of Health stipulates the types of vaccines by taking into account the considerations of the Committee of the Corona Virus Disease 2019 (COVID-19) Handling and the National Economic Recovery.
  - b. whereas based on the considerations as referred to in letter a, and to implement the provision of Article 2 paragraph (2) of President Regulation Number 99 of 2020 regarding Procurement of Vaccine and Implementation of Vaccination in the Context of the Corona Virus Disease 2019 (COVID-19) Pandemic Management, it is necessary to stipulate Minister of Health Decree regarding Stipulation of the Types of Vaccines For The Implementation of the Corona Virus Disease 2019 (COVID-19) Vaccination;
- Bearing in Mind :
- 1. Law Number 4 of 1984 regarding Outbreak of Communicable Diseases (State Gazette of the Republic of Indonesia of 1984 Number 20, Supplement to State Gazette of the Republic of Indonesia Number 3273);
  - 2. Law Number 24 of 2007 regarding Disaster Management (State Gazette of the Republic of Indonesia of 2007 Number

66, Supplement to the State Gazette of the Republic of Indonesia Number 4723);

3. Law Number 36 of 2009 regarding Health (State Gazette of the Republic of Indonesia of 2009 Number 144, Supplement to State Gazette of the Republic of Indonesia Number 5063);
4. Law Number 2 of 2020 regarding Stipulation of Government Regulation in Lieu of Law Number 1 of 2020 regarding State Finance Policy and Financial System Stability for the Handling of the Corona Virus Disease 2019 (COVID-19) Pandemic and/or In the Context of Encountering Threats that are Dangerous for the National Economy and/or Financial System Stability to become Law (State Gazette of the Republic of Indonesia of 2020 Number 134, Supplement to the State Gazette of the Republic of Indonesia Number 6516);
5. President Regulation Number 99 of 2020 regarding Procurement of Vaccine and Implementation of Vaccination in the Context of the Corona Virus Disease 2019 (COVID-19) Management (State Gazette of the Republic of Indonesia of 2020 Number 227)
6. Minister of Health Regulation Number 28 of 2020 regarding Implementation of Vaccine Procurement in the Context of the Corona Virus Disease 2019 (COVID-19) Pandemic Management (State Gazette of the Republic of Indonesia of 2020 Number 1229) as amended several times by Minister of Health Regulation Number 79 of 2020 regarding Amendment of the Minister of Health Regulation Number 28 of 2020 regarding Implementation of Vaccine Procurement in the Context of the Corona Virus Disease 2019 (COVID-19) Pandemic Management (State Gazette of the Republic of Indonesia of 2020 Number 1266);

HAS DECIDED:

- To Stipulate : DECREE OF THE MINISTER OF HEALTH REGARDING STIPULATION OF THE TYPES OF VACCINES FOR THE IMPLEMENTATION OF THE CORONA VIRUS DISEASE 2019 (COVID-19) VACCINATION.
- FIRST : To stipulate the types of vaccines of the Corona Virus Disease 2019 (COVID-19) that have been produced by PT Bio Farma (Persero), AstraZeneca, China National Pharmaceutical Group Corporation (Sinopharm), Moderna, Pfizer Inc. and BioNTech, and Sinovac Biotech Ltd., as the types of COVID-19 vaccines that may be used for the implementation of vaccination in Indonesia.
- SECOND : The types of vaccines as referred to in the FIRST Dictum are vaccines that are still in the phase of implementing the third-phase of clinical trial or have completed the third-phase of clinical trial.
- THIRD : The usage of vaccines for the implementation of the Corona Virus Disease 2019 (COVID-19) vaccination as referred to in the FIRST Dictum may only be conducted after receiving the License to Circulate (*Izin Edar*) or emergency use authorization from the National Agency of Drug and Food Control.
- FOURTH : The Minister may change the types of Corona Virus Disease 2019 (COVID-19) vaccines as referred to in the FIRST Dictum based on the recommendation of the Indonesian Technical Advisory Group on Immunization and taking into account the considerations of the Committee of the Corona Virus Disease 2019 (COVID-19) Handling and the National Economic Recovery.
- FIFTH : The vaccine procurement in accordance with the types of Corona Virus Disease 2019 (COVID-19) vaccines as referred to in the FIRST Dictum:
- a. for the needs of program vaccination implementation, shall be conducted by the Minister of Health; and

- b. for the needs of independent vaccination implementation, shall be conducted by the Minister of State-Owned Enterprises.

SIXTH : This Minister Decree shall be effective as of the date of its stipulation.
