**EXTENSION OF THE IMPLEMENTATION OF MICRO-BASED RESTRICTIONS FOR  
COMMUNITY ACTIVITIES**

**GOVERNOR OF SPECIAL CAPITAL REGION OF JAKARTA,**

- Considering : a. whereas to follow up the Instructions of the Minister of Home Affairs Number 14 of 2021 regarding the Extension of the Implementation of Micro-Based Restrictions For Community Activities and Optimizing the Corona Virus Disease 2019 Handling Post at the Village and Sub-District Level for Handling the Spread of the Corona Virus Disease 2019, it is necessary to stipulate the Decree of the Governor regarding the Extension of the Implementation of Micro-Based Restrictions For Community Activities;
- Bearing in Mind : 1. Law Number 29 of 2007 regarding the Special Capital Region of Jakarta Provincial Government as the Capital of the Unitary State of the Republic of Indonesia (State Gazette of the Republic of Indonesia of 2007 Number 93, Supplement to the State Gazette of the Republic of Indonesia Number 4744);
2. Law Number 23 of 2014 regarding Regional Government (State Gazette of the Republic of Indonesia of 2014

Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587) as amended several times, the latest by Law Number 9 of 2015 regarding the Second Amendment to Law Number 23 of 2014 regarding Regional Government (State Gazette of the Republic of Indonesia of 2015 Number 58, Supplement to the State Gazette of the Republic of Indonesia Number 5679);

3. Law Number 30 of 2014 regarding Government Administration (State Gazette of the Republic of Indonesia of 2014 Number 292, Supplement to the State Gazette of the Republic of Indonesia Number 5601);
4. Law Number 6 of 2018 regarding Health Quarantine (State Gazette of the Republic of Indonesia of 2018 Number 128, Supplement to the State Gazette of the Republic of Indonesia Number 6236);
5. Regional Regulation Number 2 of 2020 regarding Management of the Corona Virus Disease 2019 (Regional Gazette of the Special Capital Region of Jakarta Province of 2020 Number 201, Supplement to the Regional Gazette of the Special Capital Region of Jakarta Province Number 2008);
6. Governor Regulation Number 3 of 2021 regarding Implementing Regulation of the Regional Regulation Number 2 of 2020 regarding Management of the Corona Virus Disease 2019 (Regional Gazette of the Special Capital Region of Jakarta Province of 2021 Number 62002);

HAS DECIDED:

To Stipulate : DECREE OF THE GOVERNOR REGARDING THE EXTENSION OF THE IMPLEMENTATION OF MICRO-BASED RESTRICTIONS FOR COMMUNITY ACTIVITIES.

FIRST : To stipulate the Extension of the Implementation of Micro-

Based Restrictions For Community Activities for 14 (fourteen) days since June 22, 2021 until July 5, 2021.

- SECOND** : During the extension of the Implementation of Micro-Based Restrictions For Community Activities as referred to in the FIRST dictum, shall be applicable *mutatis mutandis* against the provisions of local scale strict control and the implementation of Covid-19 health protocols in accordance with the provisions of Article 42 of Governor Regulation Number 3 of 2021 regarding Implementing Regulation of Regional Regulation Number 2 of 2020 regarding Management of the Corona Virus Disease 2019.
- THIRD** : Types of Micro-Based Restrictions For Community Activities as referred to in the FIRST dictum shall be listed in the Attachment which shall be an integral part of this Governor Decree.
- FOURTH** : With the establishment of this Governor Decree, therefore Governor Decree Number 759 of 2021 regarding the Extension of the Implementation of Micro-Based Restrictions For Community Activities, shall be revoked and declared invalid.
- FIFTH** : This Governor Decree shall enter into force on June 22, 2021.
