**INSTRUCTION OF THE MINISTER OF HOME AFFAIRS NUMBER 18 OF 2021**

**REGARDING**

**THE SECOND AMENDMENT TO THE INSTRUCTION OF THE MINISTER OF HOME AFFAIRS NUMBER 15 OF 2021 REGARDING THE IMPLEMENTATION OF CORONA VIRUS DISEASE 2019 EMERGENCY RESTRICTIONS ON PUBLIC ACTIVITIES IN JAVA AND BALI**

**MINISTER OF HOME AFFAIRS,**

In an effort to maintain order and optimize the implementation of Corona Virus Disease 2019 (Covid-19) Emergency Restrictions on Public Activities (Emergency PPKM) in Java and Bali, it is necessary to amend the Instruction of the Minister of Home Affairs Number 15 of 2021 regarding Covid-19 Emergency PPKM in Java and Bali as amended by the Instruction of the Minister of Home Affairs Number 16 of 2021, specifically on the THIRD Dictum letter c number 1) and number 3) as well as letter f, in connection with the foregoing, it is instructed:

To : 1. Governors; and  
2. Regents/Mayors,

To :  
FIRST : Amend the THIRD Dictum:

- a. Letter c number 1) and number 3) so that the implementation of activities on the following sectors:
  - 1) essential sectors, such as:
    - a. finance and banking that only includes insurance, bank, pawnbroker, pension funds and other financing institutions (oriented to physical services with customers);
    - b. capital markets (oriented to services with customers involving the wellness of capital market operations);
    - c. information technology and communications including cellular operators, data centers, internet, post offices, media relating to the spread of information to the public;
    - d. hospitality industry that is not involved in handling quarantine; and
    - e. export-oriented industry whereby the company must provide proof of sample of a Notice of Exported Goods (*Pemberitahuan Ekspor Barang* or PEB) document for the last 12 (twelve) months or other documents which indicate proof of export plans and are required to provide an Operational and Industrial Activity Mobility License (*Izin Operasional dan Mobilitas Kegiatan Industri* or IOMKI),  
may operate with the following provisions:
      1. for letter a, shall be allowed to operate with a maximum capacity of 50% (fifty) percent of staff for locations related to services to the community, and 25% (twenty-five)

- percent for office administrative services to support operational activities;
- 2. for letter b to letter d, shall be allowed to operate with a maximum capacity of 50% (fifty) percent of staff; and
- 3. for letter e, shall be allowed to operate with a maximum capacity of 50% (fifty) percent of staff in production/manufacturing facilities, and 10% (ten) percent for office administrative services to support operational activities,

3) Critical Sectors:

- f. health;
- g. security and public order;
- h. disaster management;
- i. energy;
- j. logistics, transportation and distribution especially for the basic needs of the community;
- k. food and beverages as well as their supporting facilities, including for livestock/animal;
- l. fertilizers and petrochemicals;
- m. cement and building materials;
- n. national vital objects;
- o. national strategic projects;
- p. construction (public infrastructure);
- q. basic utilities (electricity, water, and waste management), may operate with the following provisions:
  - 1. for letter a to letter b, shall be allowed to operate 100% (one hundred) percent of staff without exceptions; and
  - 2. for letter c to letter l, shall be allowed to operate 100% (one hundred) percent of the staff, only for production/construction/community service facilities and for office administrative services to support operational activities, shall be imposed with a maximum of 25% (twenty-five) percent of staff.

- II. Letter f so that the implementation of construction activities for public infrastructures (construction sites and project sites) to operate 100% (one hundred) percent by applying stricter health protocols.

SECOND : This Minister Instruction is in inseparable part of:

- a. Instruction of the Minister of Home Affairs Number 15 of 2021 regarding the Implementation of Corona Virus 2019 Emergency Restrictions on Public Activities in Java and Bali; and
- b. Instruction of the Minister of Home Affairs Number 16 of 2021 regarding Amendment to Instruction of the Minister of Home Affairs Number 15 of 2021 regarding the Implementation of Corona Virus 2019 Emergency Restrictions on Public Activities in Java and Bali.

THIRD : This instruction is effective from July 09, 2021 to July 20, 2021.
