INSTRUCTION OF THE MINISTER OF HOME AFFAIRS NUMBER 19 OF 2021

REGARDING

THIRD AMENDMENT TO THE INSTRUCTION OF THE MINISTER OF HOME AFFAIRS NUMBER 15 OF 2021 REGARDING THE IMPLEMENTATION OF CORONA VIRUS DISEASE 2019 EMERGENCY RESTRICTIONS ON COMMUNITY ACTIVITIES IN JAVA AND BALI

MINISTER OF HOME AFFAIRS,

In the framework of the orderly enforcement of the Implementation of Corona Virus Disease 2019 (COVID-19) Emergency Restrictions on Community Activities (*Pemberlakuan Pembatasan Kegiatan Masyarakat Darurat* or "Emergency PPKM") in Java and Bali, Amendments must be made especially to the THIRD Dictum Letter g and Letter k of the Instruction of the Minister of Home Affairs Number 15 of 2021 regarding COVID-19 Emergency PPKM in Java and Bali, as has been amended several times, the latest by the Instruction of the Minister of Home Affairs Number 18 of 2021 R]regarding the Second Amendment to the Instruction of the Minister of Home Affairs Number 15 of 2021 regarding COVID-19 Emergency PPKM in Java and Bali, in relation to the foregoing it is therefore instructed:

To 1. Governors; and

2. Regents/Mayors,

To

FIRST

Implement the THIRD Dictum Letter g and Letter k of the Instruction of the Minister of Home Affairs Number 15 of 2021 which is amended to:

- I. Letter g, places of worship (Mosques, Prayer Rooms, Church, Temple (*Pura*), Vihara and Temple (*Klenteng*) as well as other places that are functioned as places of worship) shall not hold mass worship/religious activities during the Emergency PPKM implementation period and optimize worship activities at home; and
- II. Letter k, wedding receptions shall be temporarily suspended



during the implementation of Emergency PPKM.

SECOND

: This Ministerial Instruction is an inseparable part of:

- Instruction of the Minister of Home Affairs Number 15 of 2021 regarding the Implementation of Corona Virus Disease 2019 Emergency Restrictions on Community Activities;
- Instruction of the Minister of Home Affairs Number 16 of 2021 regarding the Amendment to the Instruction of the Minister of Home Affairs Number 15 of 2021 regarding the Implementation of Corona Virus Disease 2019 Emergency Restrictions on Community Activities; and
- c. Instruction of the Minister of Home Affairs Number 18 of 2021 regarding the Second Amendment to the Instruction of the Minister of Home Affairs Number 15 of 2021 regarding the Implementation of Corona Virus Disease 2019 Emergency Restrictions on Community Activities.

THIRD

: This Instruction of the Minister shall enter into force on July 10 until July 20, 2021.
