INSTRUCTION OF THE MINISTER OF HOME AFFAIRS NUMBER 35 OF 2021

REGARDING THE IMPLEMENTATION OF LEVEL 4, LEVEL 3, AND LEVEL 2 CORONA VIRUS DISEASE 2019 RESTRICTIONS ON PUBLIC ACTIVITIES IN JAVA AND BALI AREA

MINISTER OF HOME AFFAIRS,

Following the instruction of the President of the Republic of Indonesia which instructed for the implementation of Level 4 (four), Level 3 (three), and Level 2 (two) Corona Virus Disease 2019 (COVID-19) Restrictions on Public Activities (*Pemberlakuan Pembatasan Kegiatan Masyarakat Darurat* or "**PPKM**") in Java and Bali in accordance with the level criteria of the pandemic situation based on the assessments and to complete the instruction of the Minister of Home Affairs regarding the implementation of Level 3 (three), Level 2 (two), and Level 1 (one) COVID-19 Restrictions on Public Activities and to optimize the COVID-19 Command Handling Post at the Village and Sub-District Levels in order to control the spread of COVID-19, it is therefore instructed:

To : 1. Governors; and 2. Regents/Mayors,

- a. Governor of DKI Jakarta for Regencies/Cities with level 3 (three) criteria namely the Administrative Regency of Kepulauan Seribu, Administrative Regency of West Jakarta, Administrative Regency of East Jakarta, Administrative Regency of South Jakarta, Administrative Regency of North Jakarta, and Administrative Regency of Central Jakarta,
- b. Governor of Banten and Regents/Mayors for Regencies/Cities with the following criteria:
 - 1) Level 2 (two) namely the Regency of Serang, Regency of Lebak; and

- 2) Level 3 (three) namely the City of Cilegon, City of Serang, Regency of Pandeglang, City of South Tangerang, City of Tangerang, and Regency of Tangerang.
- c. Governor of West Java and Regents/Mayors of Regencies/Cities with the following criteria:
 - 1) Level 2 (two) namely the Regency of Tasikmalaya, Regency of Majalengka, Regency of Subang, Regency of Garut;
 - 2) Level 3 (three) namely the Regency of Kuningan, Regency of Indramayu, Regency of Purwakarta, City of Banjar, Regency of Pangandaran, Regency of Cirebon, Regency of Ciamis, Regency of Karawang, City of Tasikmalaya, City of Bogor, City of Bekasi, City of Bandung, City of Depok, City of Cimahi, Regency of Bogor, Regency of West Bandung, Regency of Bekasi, Regency of Bandung, Regency of Sumedang; and
 - 3) Level 4 (four) namely the Regency of Cianjur, City of Sukabumi, Regency of Sukabumi, and City of Cirebon,
- d. Governor of Central Java and Regents/Mayors of Regencies/Cities with the following criteria:
 - 1) Level 2 (two) namely the Regency of Kudus, Regency of Jepara;
 - 2) Level 3 (three) namely the Regency of Wonosobo, Regency of Pekalongan, Regency of Magelang, Regency of Brebes, Regency of Pemalang, Regency of Grobogan, Regency of Tegal, Regency of Pati, Regency of Banjarnegara, Regency of Batang, Regency of Rembang, Regency of Semarang, Regency of Kendal, Regency of Demak, City of Semarang, City of Pekalongan, Regency of Blora, Regency of Temanggung; and
 - 3) Level 4 (four) namely the Regency of Boyolali, Regency of Purbalingga, Regency of Wonogiri, Regency of Sukoharjo, Regency of Klaten, Regency of Kebumen, Regency of Banyumas, City of Tegal, City of Surakarta, City of Salatiga, City of Magelang, City of Sragen, Regency of Purworejo, Regency of Cilacap, and Regency of Karanganyar,
- e. The Governor of the Special Region of Yogyakarta and Regents/Mayors of Regencies/Cities with the Level 4 (four) criteria namely the Regency of Sleman, Regency of Bantul, City of Yogyakarta, Regency of Kulonprogo, and Regency of Gunungkidul,



- f. Governor of East Java and Regents/Mayors for Regencies/Cities with the following criteria:
 - 1) Level 2 (two) namely the Regency of Sampang, Regency of Pamekasan;
 - 2) Level 3 (three) namely the Regency of Pasuruan, Regency of Pacitan, Regency of Sumenep, Regency of Probolinggo, Regency of Tuban, Regency of Jember, Regency of Bojonegoro, Regency of Situbondo, Regency of Bondowoso, Regency of Nganjuk, City of Pasuruan, Regency of Sidoarjo, City of Surabaya, City of Mojokerto, Regency of Mojokerto, Regency of Lamongan, Regency of Gresik, Regency of Bangkalan; and
 - 3) Level 4 (four) namely Regency of Tulungagung, Regency of Madiun, City of Malang, City of Madiun, City of Kediri, City of Blitar, City of Batu, Regency of Trenggalek, Regency of Malang, Regency of Ponorogo, Regency of Ngawi, Regency of Magetan, City of Probolinggo, Regency of Kediri, Regency of Jombang, Regency of Blitar, Regency of Banyuwangi, and Regency of Lumajang
- g. Governor of Bali and Regents/Mayors for Regencies/Cities with the level 4 (four) criteria namely the Regency of Jembrana, Regency of Bangli, Regency of Karangasem, Regency of Badung, Regensi of Gianyar, Regency of Gianyar, Regency of Klungkung, Regency of Tabanan, Regency of Buleleng, and City of Denpasar.
- SECOND : The regional level stipulation as referred to in the FIRST Dictum shall be guided by the Indicators of Adjustment of Public Health Efforts and Social Restrictions in the Handling of the COVID-19 Pandemic as stipulated by the Minister of Health.
- THIRD : Adjustments as referred to in the SECOND Dictum shall be carried out on:
 - agglomeration areas in Jakarta, Bogor, Depok, Tangerang, Bekasi (Jabodetabek), Bandung Raya, Semarang Raya, Solo Raya, Special Region of Yogyakarta, Surabaya Raya, Malang Raya, and Bali, where the assessment of the agglomeration area is counted as a single unit; and
 - b. Areas that are actively doing data corrections,

This is done in order to encourage Regencies/Cities to make data corrections in relations to Covid-19.

FOURTH : PPKM for Regencies and Cities in Java and Bali Region with Level 4 (four) criteria as referred to in the FIRST Dictum shall be carried out by implementing the following activities:

- a. implementation of teaching and learning activities shall be carried out;
 - 1) through online learning; and
 - maximum of 25% (twenty five percent) educators and/or education staff at each educational unit may carry out the technical preparation (simulation) of National Assessment on 24 August 2021 to 2 September 2021,
- b. implementation of activities in the non-essential sectors shall be enforced with 100% (one hundred percent) Work From Home (WFH);
- c. implementation of activities in the following sectors:
 - 1) essential such as:
 - a) finance and banking which only include insurance, bank, pawnshop, futures exchange, pension fund, and financial institutions (oriented to physical service with the customers);
 - b) capital market (oriented to physical service with the customers and the capital market operations run well);
 - c) information and communication technology including cellular operator, data center, internet, post, media related to information dissemination to the public;
 - d) non-quarantine handling hotels; and
 - e) export-oriented industry where the company must present proof of the Export Declaration (*Pemberitahuan Ekspor Barang* or "**PEB**") document samples for the last 12 (twelve) months or other documents indicating an export plan and shall have an Industrial Activity Mobility and Operational Permit (*Izin Operasional dan Mobilitas Kegiatan Industri* or "**IOMKI**") issued by the Ministry of Industry,

may operate with the following conditions:

- a) for letter a) may operate with a maximum capacity of 50% (fifty percent) staff for the location related to services to the public, as well as 25% (twenty five percent) for the office administration services to support operations;
- b) for letter b) until letter d) may operate with a maximum capacity of 50% (fifty percent) staff; and

- c) for letter e) may operate with a maximum shift of 50% (fifty percent) from the total number of staff in 1 (one) shift in the production facilities/factories, as well as 10% (ten percent) for the office administration services to support operations by implementing regulations on staff's working hours and prohibition for staffs to eat together.
- essential in the government sector that provides public services which implementation cannot be delayed shall be enforced with 25% (twenty five percent) maximum Work From Office (WFO) staff with strict health protocols;
- 3) critical sectors such as:
 - a) health;
 - b) security and order;
 - c) disaster management;
 - d) energy;
 - e) logistics, transportation, and distribution especially for the public's basic needs;
 - f) food and beverage industry and its support, including for livestock and pets;
 - g) fertilizer and petrochemicals;
 - h) cement and building materials;
 - i) national vital objects;
 - j) national strategic projects;
 - k) construction (public infrastructure);
 - I) basic utilities (electricity, water, and waste management)

may be operated with the following conditions:

- a) for letter a) and letter b) may operate with 100% (one hundred percent) staff without any exception;
- b) for letter c) until letter l) may operate with 100% (one hundred percent) staff, only in the production facilities/construction/services to the public and for the office administration services to support operations, shall be enforced with a maximum of 25% (twenty-five percent) WFO staff,
- companies that fall into the sector in letters d), e), f), g), h), k), and l) are required to use the Peduli Lindungi application starting from 6 September 2021 in order to screen all incoming

employees and visitors which enter the production/construction/service facilities and office administration area; and

- companies that fall into sector included within letter c) shall be required to obtain recommendation from the relevant Ministries governing the technicality of that particular sector before gaining access to use the *Peduli Lindungi* application,
- for supermarkets, traditional markets, grocery stores, and convenience stores that sell daily necessities, its operating hours are limited until 20:00 local time with a visitor capacity of 50% (fifty percent); and
- 5) for pharmacies and drugstores may be open for 24 (twenty four) hours,
- d. public markets which sell non-daily necessities may operate up until 15:00 local time with a maximum capacity of 50% (fifty percent);
- e. street hawkers, grocery stores, voucher agents/outlets, barber shops/salons, laundry, street vendors, small vehicles repair shops, vehicle wash outlets and others with similar fields may operate by implementing strict health protocols until 20:00 local time, in which the technical regulations shall be governed by the Regional Government;
- f. implementation of dining/drinking activities in public places:
 - food stalls/*warteg*, street vendors, snack stalls and alike may operate by implementing strict health protocols until 20:00 local time with a maximum of 3 (three) people dine in the place and a maximum of 30 (thirty) minutes of mealtime. Further technical regulations are regulated by the Regional Government;
 - 2) restaurants/diners, cafes that are located in closed buildings/shops, both those located in separate locations and those located in shopping centers/malls, shall only accept the delivery/take away and shall not accept dine-in. Further technical regulations are regulated by the Regional Government; and
 - 3) restaurants/diners and cafes with open spaces services are permitted to open with strict health protocols until 20:00 local time with a maximum capacity of 25% (twenty five percent), one table may only consist of a maximum of 2 (two) people and a maximum of 30 (thirty) minutes of mealtime and its technical regulations are regulated by the Regional Government.

- g. activities in shopping centers/malls/trade centers shall be temporarily closed except for access to store employees who serves online services with a maximum of 3 (three) people in each shop, restaurant, supermarket, and convenience stores, which may be permitted with due regard to the provisions under the FOURTH Dictum letter C.4 and F.2
- h. for the Regency of Sleman, Regency of Bantul, City of Yogyakarta, Regency of Kulonprogo, and Regency of Gunungkidul, Regency of Wonogiri, Regency of Sukoharjo, Regency of Sragen, City of Surakarta, Regency of Klaten, Regency of Karanganyar, and Regency of Boyolali, the trial of the implementation of health protocols shall be carried out in shopping center/mall/trade center under these following conditions:
 - activities in shopping centers/malls/trade centers may be allowed to operate in a maximum of 50% (fifty percent) capacity from 10:00 to 20:00 local time with health protocols as regulated by the Ministry of Trade;
 - mandatory use of the *Peduli Lindungi* application to screen all the visitors and employees of the related shopping centers/mall/trade centers;
 - restaurants/diners, cafes which are located in shopping centers/malls shall only accept the delivery/take away and shall not accept dine-in;
 - individuals under the age of 12 (twelve) years and above 70 (seventy) years are prohibited to enter the shopping centers/malls/trade centers; and
 - 5) cinemas, children's playground, and entertainment venues in the shopping centers/malls/trade centers shall be closed,
- i. implementation of construction activities for public infrastructure (construction sites and project sites) may operate 100% (one hundred percent) by implementing stricter health protocols;
- j. places of worship (Mosques, Prayer Rooms, Churches, Temples (*Pura*), Viharas and Temples (*Klenteng*) as well as other public places that function as places of worship) with a maximum capacity of 50% (fifty percent) or 50 (fifty) persons by implementing stricter health protocols with due regard to the technical regulations as regulated by the Ministry of Religion;
- k. public facilities (public areas, public parks, public tourist attractions, and other public areas) shall be temporarily closed;



- arts, cultural, sports and social activities (art locations, culture, sports facilities, and social activities that can cause crowds and masses) shall be temporarily closed;
- m. public transportations (public transport, mass transportation, taxis (conventional and online) and rental vehicles) shall be enforced with a maximum capacity arrangement of 50% (fifty percent) by applying stricter health protocols;
- n. wedding receptions are prohibited during the implementation of Level 4 (four) PPKM;
- o. domestic travelers using private cars, motorcycles and long-distance public transport (airplanes, buses, ships, and trains) must:
 - present their vaccination cards (minimum of the first dose of the vaccine);
 - 2) present a D-2 PCR results for airplanes, as well as D-1 Antigen results, for private cars, motorcycles, buses, trains, and ships;
 - 3) the provisions as referred to in number 1) and number 2) only applies for arrivals from outside Java and Bali or departures from Java and Bali to outside Java and Bali and do not apply to transportation within the agglomeration area for example for the Jabodetabek area; and
 - 4) for travelers who used airplanes to travel between cities and regencies within Java and Bali shall present a D-1 negative Antigen result provided that the travelers have received the second dose of the vaccine, and D-2 negative PCR result if the traveler has only received the first dose of the vaccine; and
 - 5) for drivers of logistics vehicles and other transport of goods are excluded from the provision of having a vaccination card.
- p. to wear masks correctly and consistently when carrying out activities outside the house and not allowed to use face shields without wearing masks.
- q. implementation of PPKM Neighborhood Units (*Rukun Tetangga* or "RT")/Community Units (*Rukun Warga* or "RW"), Village/Sub-District and District shall remain in force by activating the Posts at every level by looking at the zoning criteria for regional control
- : PPKM for Regencies and Cities in Java and Bali Region with Level 3 (three) criteria as referred to in the FIRST Dictum shall be carried out by implementing the following activities:

- a. implementation of teaching and learning activities shall be conducted through a limited face-to-face learning and/or online learning with due regard to the Joint Decree of the Minister of Education and Culture, Minister of Religion, Minister of Health, and the Minister of Home Affairs No. 03/KB/2021, Number 384 of 2021, No. HK.01.08/MENKES/4242/2021, Number 440-717 of 2021 concerning the Guidelines of Implementing Academic Activities during the Coronavirus Disease 2019 (COVID-19) Pandemic and for educational units that carry out a limited face-to-face learning shall be conducted with a maximum capacity of 50% (fifty percent), except for:
 - SDLB, MILB, SMPLB, SMLB, and MALB with a maximum capacity of 62% (sixty two percent) up to 100% (one hundred percent) by maintaining a minimum distance of 1.5m (one point five meters) and a maximum of 5 (five) students per class; and
 - PAUD with a maximum capacity of 33% (thirty three percent) by maintaining a minimum distance of 1.5m (one point five meters) and a maximum of 5 (five) students per class,
- b. implementation of activities in the non-essential sectors shall be enforced with 100% (one hundred percent) Work From Home (WFH);
- c. implementation of activities in the following sectors:
 - 1) essential such as:
 - a) finance and banking which only include insurance, bank, pawnshop, futures exchange, pension fund, and financial institutions (oriented to physical service with the customers);
 - b) capital market (oriented to physical service with the customers and the proper operations of the capital market);
 - c) information and communication technology including cellular operator, data center, internet, post, media related to information dissemination to the public;
 - d) non-quarantine handling hotels; and
 - e) export-oriented industry where the company must present proof of the Export of Goods Declaration (*Pemberitahuan Ekspor Barang* or "*PEB*") document samples for the last 12 (twelve) months or other documents indicating an export plan and shall have an Industrial Activity Mobility and Operational Permit (*Izin Operasional dan Mobilitas Kegiatan Industri* or "IOMKI") issued by the Ministry of Industry,



may operate with the following conditions:

- a) for letter a) may operate with a maximum capacity of 50% (fifty percent) staff for the location related to services to the public, as well as 25% (twenty five percent) for the office administration services to support operations;
- b) for letter b) until letter d) may operate with a maximum capacity of 50% (fifty percent) staff; and
- c) for letter e) may only operate with a shift arrangement with maximum capacity of 50% (fifty percent) staff for each shifts in the production facilities/factories, as well as 10% (ten percent) for the office administration services for operational support, by implementing health protocol, regulating the entrance and exits of the employees along with prohibiting the employees to eat in groups,
- essential in the government sector that provides public services which implementation cannot be delayed shall be enforced with 25% (twenty five percent) maximum WFO staff with strict health protocols;
- 3) critical sectors such as:
 - a) health;
 - b) security and order;
 - c) disaster management;
 - d) energy;
 - e) logistics, transportation, and distribution especially for the public's basic needs;
 - f) food and beverage industry and its support, including for livestock and pets;
 - g) fertilizer and petrochemicals;
 - h) cement and building materials;
 - i) national vital objects;
 - j) national strategic projects;
 - k) construction (public infrastructure);
 - I) basic utilities (electricity, water, and waste management) may operate with the following conditions:
 - a) for letter a) and letter b) may operate with 100% (one hundred percent) staff without any exception: and

- b) for letter c) until letter l) may operate with 100% (one hundred percent) maximum staff, only in the production facilities/construction/services to the public and for the office administration services to support operations, shall be enforced with a maximum of 25% (twenty-five percent) staff;
- c) companies that fall into the sector of letters d), e), f), g), h), k), and l) are required to use the *Peduli Lindungi* application starting from September 6, 2021 in order to screen all incoming employees and visitors which enter the production/construction/service facilities and office administration area; and
- companies that fall into the sector category in accordance with letter c) must be required to obtain recommendation from the relevant ministries governing the technicality of that particular sector before gaining access to use the Peduli Lindungi application,
- for supermarkets, traditional markets, grocery stores, and convenience stores that sell daily necessities, its operating hours are limited until 20:00 local time with a visitor capacity of 50% (fifty percent); and
- 5) for pharmacies and drugstores may be open for 24 (twenty four) hours,
- d. public markets which sell non-daily necessities may operate up until 15:00 local time with a maximum capacity of 50% (fifty percent);
- e. street hawkers, grocery stores, voucher agents/outlets, barber shops/salons, laundry, street vendors, small car repair shops, car wash outlets and others with similar fields may operate by implementing strict health protocols until 20:00 local time, in which the technical regulations shall be governed by the Regional Government;
- f. implementation of dining/drinking activities in public places:
 - food stalls/*warteg*, street vendors, snack stalls and alike may operate by implementing strict health protocols until 20:00 local time with a maximum capacity of 25% (twenty five percent) and a maximum of 30 (thirty) minutes of mealtime;
 - restaurants/diners, cafes that are located in closed buildings/shops which are located in separate locations shall only accept the delivery/take away and shall not accept dine-in.

- 3) restaurants/diners and cafes with open spaces services may operate with strict health protocols until 20:00 local time with a maximum capacity of 25% (twenty five percent), one table may only consist of a maximum of 2 (two) people and a maximum of 30 (thirty) minutes of mealtime and its technical regulations are regulated by the Regional Government; and
- 4) technical regulations in number 1) to 3) are regulated by Regional Government
- g. activities in shopping centers/malls/trade centers may be commenced under these following conditions:
 - maximum capacity of 50% (fifty percent) and operating hours are up to 20:00 local time with due regard to provisions within letter C.4 and F.2 with health protocols as regulated by the Ministry of Trade;
 - mandatory use of the *Peduli Lindungi* application to screen all the visitors and employees of the shopping centers/mall/trade centers;
 - restaurants/diners, cafe which are located in shopping centers/malls/trade centers may accept dine in with a maximum capacity of 25% (twenty five percent), one table may only consist of a maximum of 2 (two) people and a maximum of 30 (thirty) minutes of mealtime;
 - 4) individuals under the age of 12 (twelve) years are not permitted to enter the shopping centers/malls/trade centers;
 - 5) cinemas, children's playground, and entertainment venues in the shopping centers/malls/trade centers shall be closed,
- h. implementation of construction activities for public infrastructure (construction sites and project sites) shall operate 100% (one hundred percent) and small scale construction is permitted of a maximum of 10 (ten) people by implementing stricter health protocols;
- i. places of worship (Mosques, Prayer Rooms, Churches, Temples (Pura), Viharas and Temples (Klenteng) as well as other public places that function as places of worship) may hold congregational worship/religious activities during the implementation of Level 3 (three) PPKM with a maximum capacity of 50% (fifty) percent or 50 (fifty) people by implementing stricter health protocols with due regard to the technical regulations as regulated by the Ministry of Religion;
- j. public facilities (public areas, public parks, public tourist attractions, and other public areas) shall be temporarily closed;

- arts, cultural, sports and social activities (art locations, culture, sports facilities, and social activities that can cause crowds and masses) shall be temporarily closed, except for:
 - sports activities shall be carried out in open spaces (outdoor) either individually or in small groups of a maximum 4 (four) people, shall not involve physical contact with other people and do not routinely require individual interaction in close proximity and could be implemented with a strict health protocol. Sports activities within and enclosed space, activities that are done in group and enclosed sports competitions shall be temporarily closed;
 - outdoor sports facilities may be opened with a maximum capacity of 50% (fifty percent);
 - masks must be used during sports activities, except for sport activities that require the participants to take off their masks, such as swimming. For sports activities where the mask cannot be worn, the mask shall only be removed when the sports activities are conducted;
 - 4) temperature checks shall be carried out for each person who enter the sports facilities;
 - 5) restaurants/diners and cafe inside the sports facilities are not permitted to accept dine-in;
 - 6) supporting facilities such as lockers, VIP rooms, and the bathroom are not permitted to be used except for toilet access;
 - 7) sports facilities users are not permitted to commune before and after doing sports activities and must keep their distance;
 - 8) screening for visitors at the sports facility shall use the *Peduli Lindungi* application;
 - 9) sports facilities that violate health protocols will be subjected to sanctions in the form of temporary closure,
- public transportations (public transport, mass transportation, taxis (conventional and online) and rental vehicles) shall be enforced with a maximum capacity arrangement of 70% (seventy percent) by applying stricter health protocols;
- m. implementation of wedding receptions are permitted with a maximum of 20 (twenty) invitations and shall not conduct dine-in on the venue by implementing a stricter health protocol;



- n. domestic travelers using private cars, motorcycles and long-distance public transport (airplanes, buses, ships, and trains) must:
 - 1) present their vaccination cards (minimum of the first dose of the vaccine);
 - 2) present a D-2 PCR results for airplanes, as well as D-1 Antigen results, for private cars, motorcycles, buses, trains, and ships;

2) tracing should be carried out until there are more than 15 close contacts per confirmed case. Quarantine shall be carried out for those identified as close contacts. Once being identified having close contacts, entry-test and quarantine shall be carried out. If the test result is positive, it is necessary to carry out isolation. If the test result is negative, it is necessary to continue quarantine. On the 5th day of quarantine, it is necessary to carry out again an exittest to see whether the virus is detected after/during the incubation period. If negative, the patient is considered to have completed the quarantine; and



- treatment shall be comprehensively carried out according to the severity of the symptoms. Only patients with moderate, severe, and critical symptoms need to be treated in the hospital. Isolation shall be carried out strictly to prevent transmissions,
- k. efforts to accelerate vaccination must continue to be carried out to protect as many people and these efforts are carried out to lower the rate of transmission and prioritize the safety of those who are vulnerable to mortality (such as elderly, people with comorbidities), taking into account the limited health capacity and long-term impact of COVID-19 infection
- THIRTEENTH : Governors, Mayors, and Regents:
 - a. accelerate social aid distribution process as well as social safety net provided from the Regional Revenues and Expenditures Budget (*Anggaran Pembelanjaan dan Belanja Daerah* – "**APBD**"), if there is a need for additional funding for budgeting and distribution of social aid and social safety net in supporting the implementation of COVID-19 PPKM, then:

- a) Regents/Mayors to accelerate the evaluation of Village Revenue and Expenditure Budget (*Anggaran Pendapatan dan Belanja Desa* "APBDesa") for Villages that have not stipulated Village Regulations regarding APBDesa, ratification of Human Development Cadre (*Kader Pembangunan Manusia* "KPM") data by the Regional government, recording of KPM Data of BLT-DD recipients on State Budget Treasury System Online Monitoring (*Online Monitoring Sistem Perbendaharaan Anggaran Negara* "Om-SPAN") in accordance with the provisions of the laws and regulations; and
- b) Head of the Village to conduct data recording and stipulation of KPM, and follow up with the implementation of BLT-DD in accordance with the provisions of laws and regulations,

- FOURTEENTH : Funding for the Implementation of PPKM due to the COVID-19 Pandemic sourced from APBD:

The results of the budget allocation for rescheduling program and activity achievements are diverted to unexpected expenditures; and

 - 3) Law Number 6 of 2018 regarding Health Quarantine; and
 - 4) Regional Regulation, Regional Head Regulation; as well as
 - 5) Provisions of other relevant laws and regulations.
- SIXTEENTH : This Ministerial Instruction shall come into force on 24 August 2021 until 30 August 2021.
