# INSTRUCTION OF THE MINISTER OF HOME AFFAIRS NUMBER 43 OF 2021

## **REGARDING**

THE IMPLEMENTATION OF LEVEL 4, LEVEL 3, AND LEVEL 2 CORONA VIRUS DISEASE 2019 RESTRICTIONS ON PUBLIC ACTIVITIES IN JAVA AND BALI

## MINISTER OF HOME AFFAIRS,

Following the instruction of the President of the Republic of Indonesia which instructed for the implementation of Level 4 (four), Level 3 (three), and Level 2 (two) Corona Virus Disease 2019 (COVID-19) Restrictions on Public Activities (*Pemberlakuan Pembatasan Kegiatan Masyarakat Darurat* or "**PPKM**") in Java and Bali in accordance with the criteria of the pandemic situation level based on the assessments and to complete the implementation of PPKM and Optimizing the Corona Virus Disease 2019 Command Handling Post at the Village and Sub-District Level for Handling the Spread of the COVID- 2019, it is therefore instructed:

2. Regents/Mayors,

To

FIRST : Specifically To:

- a. The Governor of DKI Jakarta for Regencies/Cities with level 3 (three) criteria namely the Administrative Regency of Kepulauan Seribu, Administrative City of West Jakarta, Administrative City of East Jakarta, Administrative City of South Jakarta, Administrative City of North Jakarta, and Administrative City of Central Jakarta,
- b. The Governor of Banten and Regents/Mayors of Regencies/Cities with the following criteria:
  - 1) level 2 (two) namely Regency of Serang, Regency of Pandeglang, Regency of Lebak; and
  - 2) level 3 (three) namely City of Tangerang, City of Cilegon, Regency of Tangerang, City of South Tangerang, and City of Serang,
- c. The Governor of West Java and Regents/Mayors of Regencies/Cities with the following criteria:



- level 2 (two) namely Regency of Kuningan, Regency of Sukabumi, Regency of Pangandaran, Regency of Majalengka, Regency of Karawang, Regency of Indramayu, Regency of Cianjur, Regency of Ciamis, Regency of Subang, Regency of Garut; and
- 2) level 3 (three) namely City of Sukabumi, City of Bogor, City of Bekasi, City of Bandung, Regency of Tasikmalaya, Regency of Purwakarta, City of Tasikmalaya, City of Depok, City of Cimahi, City of Banjar, City of Cirebon, Regency of Cirebon, Regency of Bogor, Regency of Bekasi, Regency of West Bandung, Regency of Bandung, and Regency of Sumedang,
- d. The Governor of Central Java and Regents/Mayors of Regencies/Cities with the following criteria:
  - level 2 (two) namely Regency of Temanggung, Regency of Rembang, Regency of Pemalang, Regency of Pati, Regency of Kudus, City of Tegal, City of Semarang, City of Pekalongan, Regency of Kendal, Regency of Banjarnegara, Regency of Semarang, Regency of Pekalongan, Regency of Jepara, Regency of Grobogan, Regency of Blora, Regency of Batang, Regency of Demak; and
  - 2) level 3 (three) namely Regency of Wonosobo, Regency of Wonogiri, Regency of Tegal, Regency of Sukoharjo, Regency of Sragen, Regency of Purworejo, Regency of Purbalingga, Regency of Magelang, City of Surakarta, City of Magelang, Regency of Klaten, Regency of Kebumen, Regency of Karanganyar, Regency of Cilacap, Regency of Banyumas, Regency of Brebes, City of Salatiga, Regency of Boyolali,
- e. The Governor of the Special Region of Yogyakarta and Regents/Mayors of Regencies/Cities with the Level 3 (three) criteria namely: Regency of Sleman, Regency of Bantul, and City of Yogyakarta, Regency of Kulonprogo, and Regency of Gunungkidul,
- f. The Governor of East Java and Regents/Mayors for Regencies/Cities with the following criteria:
  - level 2 (two) namely City of Kediri, Regency of Jombang, Regency of Banyuwangi, Regency of Tuban, Regency of Sumenep, Regency of Sampang, Regency of Probolinggo, Regency of Pasuruan, Regency of Pamekasan, City of Pasuruan, Regency of Jember, Regency of Bojonegoro; and



- 2) level 3 (three) namely Regency of Tulungagung, Regency of Trenggalek, Regency of Situbondo, Regency of Sidoarjo, Regency of Ponorogo, Regency of Pacitan, Regency of Ngawi, Regency of Magetan, Regency of Madiun, Regency of Lumajang, City of Surabaya, City of Probolinggo, City of Mojokerto, City of Malang, City of Batu, Regency of Kediri, Regency of Bondowoso, Regency of Blitar, Regency of Nganjuk, Regency of Mojokerto, Regency of Malang, Regency of Lamongan, Regency of Gresik, City of Madiun and Regency of Bangkalan,
- g. The Governor of Bali and Regents/Mayors for Regencies/Cities with level 3 (three) criteria namely Regency of Jembrana, Regency of Bangli, Regency of Karangasem, Regency of Badung, Regency of Gianyar, Regency of Klungkung, Regency of Tabanan, Regency of Buleleng, and City of Denpasar.

SECOND

- The regional level stipulation as referred to in the FIRST Dictum shall be guided by the Indicators of Adjustment of Public Health Efforts and Social Restrictions in the Handling the COVID-19 Pandemic stipulated by the Minister of Health and added with indicators of total achievement of dose 1 (one) vaccination and dose 1 (one) vaccination for seniors over 60 (sixty) years of age from the vaccination target with the following conditions:
- a. reduction in the Regency/City level from level 3 (three) to level 2 (two), with a minimum of 50% (fifty percent) total achievement of dose 1 (one) vaccination and a minimum of 40% (forty percent) total achievement of dose 1 (one) vaccination for seniors over 60 years of age.
- b. reduction in the Regency/City level from level 2 (two) to level 1 (one) with a minimum of 70% (seventy percent) total achievement of dose 1 (one) vaccination and a minimum of 60% (sixty percent) total achievement of dose 1 (one) vaccination for seniors over 60 years of age.
- c. for Regencies/Cities with level 2 (two) in the Instruction of the Minister of Home Affairs Number 42 of 2021 and remaining at level 2 (two) or level 1 (one) based on the Indicators of Adjustment of Public Health Efforts and Social Restrictions in the Handling the COVID-19 Pandemic per September 12, 2021 will be given 2 (two) weeks to achieve the vaccination target as referred to in letter a and letter b, provided if the vaccination target is not achieved within 2 (two) weeks, the Regency/City level will increase to level 3 (three).



## THIRD

: The Adjustment as referred to in the SECOND Dictum is also carried out on:

- a. agglomeration areas in Jakarta, Bogor, Depok, Tangerang, Bekasi (Jabodetabek), Bandung Raya, Semarang Raya, Solo Raya, Special Region of Yogyakarta, Surabaya Raya, Malang Raya, Magelang City and Magelang Regency, as well as Bali, where the assessment of the agglomeration area is calculated as a single unit and for the Indicators of Adjustment of Public Health and Social Restrictions in Handling the COVID-19 Pandemic determined by the Minister of Health as well as for indicators of vaccination achievement, assessment of the agglomeration area will follow the Regency/City with the lowest vaccination achievement;
- regions that are actively conducting data corrections, this is done in order to encourage the Regency/City to correct data related to COVID-19.

## **FOURTH**

PPKM for Regencies and Cities in Java and Bali area with level 4 (four) criteria as referred to in the FIRST Dictum shall be carried out by implementing the following activities:

- a. implementation of teaching and learning activities in education units shall be conducted through distance learning;
- b. implementation of activities in the non-essential sectors shall be enforced with 100% (one hundred percent) Work From Home (WFH);
- c. implementation of activities in the following sectors:
  - 1) essential such as:

Fax:

- a) finance and banking, only include insurance, banks, pawn shops, futures exchange, pension funds, and financial institutions (oriented to physical service with the customers);
- b) capital market (oriented to physical service with the customers and the capital market operations to run properly);
- information and communication technology including cellular operator, data center, internet, media related to information dissemination to the public;
- d) non-quarantine handling hotels; and
- e) export-oriented and supporting industries where the company must present proof of the Export of Goods Declaration (*Pemberitahuan Ekspor Barang* or "**PEB**") document samples for the last 12 (twelve) months or other documents indicating an



export plan and shall have an Industrial Activity Mobility and Operational Permit (*Izin Operasional dan Mobilitas Kegiatan Industri* or "**IOMKI**") by taking into account the technical arrangements from the Ministry of Industry,

may operate with the following conditions:

- a) for letter a) may operate with a maximum capacity of 50% (fifty percent) staff for the location related to services to the public as well as 25% (twenty-five percent) for the office administration services to support operations;
- b) for letter b) until letter c) may operate with a maximum capacity of 50% (fifty percent) staff; and
- c) for letter d):
  - (1) must use the *PeduliLindungi* application to conduct screening towards employees and visitors:
  - (2) a maximum capacity of 50% (fifty percent) and only visitors with the Green and Yellow categories in the *PeduliLindungi* application may enter;
  - (3) facilities for fitness center/gym, lounge room/meeting room, and meeting room with large capacity/ballroom are temporarily closed; and
  - (4) visitors under the age of 12 (twelve) years must show a negative result of Antigen (D-1)/PCR (D-2),
  - d) for letter e):
    - (1) can only operate 1 (one) shift with maximum capacity of 50% (fifty percent) of staff only in production facilities/factories;
    - (2) 10% (ten percent) of office administration services to support operations;
    - (3) Number (1) (one) and number (2) (two) are carried out with strict implementation of Health protocols; and
    - (4) must use the *PeduliLindungi* application, regulating entry and exit, and employees shall not have meals at the same time,
- 2) essential in the government sector following the technical provisions issued by the Ministry of State and Bureaucratic Reform.
- 3) critical, such as:
  - a) health;
  - b) security and order;



- c) disaster management;
- d) energy;
- e) logistics, postal, transportation and distribution especially for the public's basic needs;
- f) food and beverage and its supporting industries, including for livestock/pets;
- g) fertilizers and petrochemicals;
- h) cement and building materials;
- i) national vital objects;
- i) national strategic projects;
- k) construction (public infrastructure including telecommunications and broadcasting infrastructure); and
- basic utilities (electricity, water, and waste management),
   may be operated with the following conditions:
- a) for letter a) and letter b) may operate with 100% (one hundred percent) staff without any exception; and
- b) for letter c) until letter l) may operate with a maximum of 100% (one hundred percent) staff, only in the facilities of production/construction/services to the public and for the office administration services to support operations, shall be enforced with a maximum of 25% (twenty-five percent) staff WFO
- c) companies included in sectors mentioned in letters d), e), f), g), h), k), and l) are required to use the *PeduliLindungi* application to conduct screening towards all employees and visitors who enter production/construction/office administration services and areas; and
- d) companies that are included in the sector category according to letter c) are required to obtain a recommendation from relevant ministry governing the technicality of that particular sector before gaining access to use the *PeduliLindungi* application.
- for supermarkets, hypermarkets, traditional markets, convenience stores, and grocery stores that sell daily necessities, operating hours are limited until 21:00 local time with a 50% (fifty percent) visitor capacity;
- 5) pharmacies and drugstores may be open for 24 (twenty four) hours,



- d. public markets that sell non-daily necessities may operate with a maximum capacity of 50% (fifty percent) and operating hours until 17.00 local time;
- e. street vendors, convenience stores, voucher agents/outlets, barbershops, laundry, hawkers, small repair shops, vehicle washes, and others of its kind are allowed to open with strict health protocols until 21.00 local time and technical regulations made by the Regional Government.
- f. implementation of dining/drinking activities in public places:
  - food stalls/warteg, street vendors, hawker stalls, and others of its kind are allowed to open with strict health protocols until 20.00 local time with a maximum capacity of 3 (three) customers dining at the place and a maximum of 30 (thirty) minutes of mealtime. Further technical regulations are regulated by the Regional Government;
  - restaurants/diners, cafes that are located in closed buildings/shops, both in separate locations and in shopping centers/malls, shall only accept the delivery/take away and shall not accept dine-ins, with technical regulations governed by the Regional Government;
  - 3) restaurants/diners, cafes that are located in open area may be allowed to open with strict health protocols until 20.00 local time with a maximum capacity of 25% (twenty five percent), one table for a maximum of 2 (two) people, and a maximum of 30 (thirty) minutes of mealtime, with technical regulations governed by the Regional Government,
- g. activities in shopping centers/malls/trade centers shall be temporarily closed except for access to store employee who serves online sales with a maximum of 3 (three) people per shop, restaurant, supermarket, and grocery store, which may be allowed by observing the provisions in the FOURTH dictum points c.4 and f.2;
- implementation of construction activities for public infrastructure (construction sites and project sites) may operate 100% (one hundred percent) by implementing stricter health protocols;
- i. places of worship (Mosques, Prayer Rooms, Churches, Temples (*Pura*), Viharas and Temples (*Klenteng*) as well as other public places that function as places of worship) may hold congregational worship/religious activities with a maximum capacity of 50% (fifty



- percent) or 50 (fifty) persons by implementing stricter health protocols and considering the technical requirements set forth by the Ministry of Religion;
- j. public facilities (public areas, public parks, public tourist attractions, and other public areas) shall be temporarily closed;
- arts, cultural, sports and social activities (locations of art, culture, sports facilities, and social activities that may cause crowds and masses) shall be temporarily closed;
- public transportations (public transport, mass transportation, taxis (conventional and online) and rental vehicles) shall be enforced with a maximum capacity arrangement of 50% (fifty percent) by implementing stricter health protocols;
- m. wedding receptions are prohibited during the implementation of Level 4 (four) PPKM;
- n. domestic travelers using private cars, motorcycles and long-distance public transport (airplanes, buses, ships, and trains) must:
  - present their vaccination cards (minimum of the first dose of the vaccine);
  - 2) present (D-2) PCR results for airplanes, as well as (D-1) Antigen results, for private cars, motorcycles, buses, trains, and ships;
  - the provisions referred to in number 1) and number 2) only apply for arrivals and departures to and from Java and Bali and do not apply to transportation within the agglomeration area for example for the Jabodetabek area;
  - 4) for travel by airplane between cities or districts within Java Bali may present a negative Antigen result (D-1) if the second dose of vaccination has been obtained, and negative PCR result (D-2) if dose 1 of the vaccine has been obtained; and
  - 5) for drivers of logistics vehicles and other transport of goods are excluded from the provision of having a vaccination card;
- to wear masks correctly and consistently when carrying out activities outside the house and not allowed to use face shields without wearing masks; and
- p. implementation of PPKM in Neighborhood Units (*Rukun Tetangga* or "RT"/Community Units (*Rukun Warga* or "RW"), Village/Sub-District and District shall remain in force by activating the Command Posts at every level by looking at the zoning criteria for regional control.



### FIFTH

- PPKM for Regencies and Cities in Java and Bali with Level 3 (three) criteria as referred to in the FIRST Dictum shall be carried out by implementing the following activities:
- a. implementation of learning in the education units shall be conducted through limited face-to-face learning and/or distance learning based on Joint Decree of the Ministry of Education and Culture, Ministry of Religion, Ministry Health and the Ministry of Home Affairs Number 03/KB/202I, Number 384 2021, Number of HK.01.08/MENKES/4242/2021, Number 440-717 of 2021 Guidelines Implementation of Learning in the Coronavirus Disease 2019 (COVID-19) Pandemic and for educational units that carry out face-to-face learning is limited to a maximum capacity of 50% (fifty percent), unless for:
  - 1) Special Needs Primary School (Sekolah Dasar Luar Biasa or "SDLB"), Special Needs Madrasah Ibtidaiyah (Madrasah Ibtidaiyah Luar Biasa or "MILB"), Special Needs Middle School (Sekolah Menengah Pertama Luar Biasa or "SMPLB"), Special Needs High School (Sekolah Menengah Atas Luar Biasa or "SMALB"), and Special Needs Madrasah Aliyah (Madrasah Aliyah Luar Biasa or "MALB") with a maximum of 62% (sixty two percent) up to 100% (one hundred percent) by maintaining a minimum distance of 1.5m (one point five meters) and a maximum of 5 (five) students per class; and
  - 2) Early Childhood Education (*Pendidikan Anak Usia Dini* or "**PAUD**") with a maximum of 33% (thirty three percent) by maintaining a minimum distance of 1.5 (one poinr five meters) and a maximum of 5 (five) students per class,
- b. implementation of activities in the non-essential sectors shall be enforced with 25% (twenty five percent) of Work From Office (WFO) for the employees who have been vaccinated and are required to use *PeduliLindungi* application at the entrance and exit doors of the workplace;
- c. implementation of activities in the sectors of:
  - 1) essential such as:
    - a) finance and banking, only include insurance, banks, pawn shops, pension funds, and financial institutions (oriented to physical service with the customers



- b) capital market (oriented to physical service with the customers and the capital market operations to run properly);
- c) information and communication technology including cellular operator, data center, internet, media related to information dissemination to the public;
- d) non-quarantine handling hotels; and
- e) export-oriented industry where the company must present proof of the Export Declaration (*Pemberitahuan Ekspor Barang* or "**PEB**") document samples for the last 12 (twelve) months or other documents indicating an export plan and shall have an Industrial Activity Mobility and Operational Permit (*Izin Operasional dan Mobilitas Kegiatan Industri* or "**IOMKI**") by taking into account the technical arrangements from the Ministry of Industry,

may operate with the following conditions:

- a) for letter a) may operate with a maximum capacity of 50% (fifty percent) staff for the location related to services to the public, as well as 25% (twenty five percent) for the office administration services to support operations.
- b) for letter b) until letter c) may operate with a maximum capacity of 50% (fifty percent) staff;
- c) for letter d):
  - (1) must use the *PeduliLindungi* application to conduct screening towards all employees and visitors:
  - (2) a maximum capacity of 50% (fifty percent) and only visitors with the Green and Yellow categories in the *PeduliLindungi* application may enter;
  - (3) facilities for fitness center/gym, lounge room/meeting room and meeting room with large capacity/ballroom may allowed to open using *PeduliLindungi* application with a maximum capacity of 50% (fifty percent), as well as the provision of food and beverages at the facility meeting room with large capacity/ballroom served in a box and no dish buffet; and
  - (4) visitors under the age of 12 (twelve) years must present a negative result of Antigen (Day-1)/PCR (Day-2),
- d) for letter e):



- (1) can only operate with shift setting with maximum capacity of 50% (fifty percent) of staff for each shift only in production facilities/factories;
- (2) 10% office administration services to support operations;
- (3) Number (1) (one) and number (2) (two) are carried out with implementation of Health protocols; and
- (4) must use the *PeduliLindungi* application for entry and exit arrangements,
- (5) employees shall not be eating in a group
- 2) essential in the government sector following technical provisions issued by Ministry of State and Bureaucratic Reform.
- 3) critical such as:
  - a) health;
  - b) security and order;
  - c) disaster management;
  - d) energy;
  - e) logistics, postal, transportation, and distribution especially for the public's basic needs;
  - f) food and beverage industry and its support, including for livestock and pets;
  - g) fertilizer and petrochemicals;
  - h) cement and building materials;
  - national vital objects;
  - i) national strategic projects;
  - k) construction (public infrastructure including telecommunications and broadcasting infrastructure);
  - I) basic utilities (electricity, water, and waste management);

may be operated with the following conditions:

- a) for letter a) and letter b) may operate with 100% (one hundred percent) staff without any exception; and
- b) for letter c) until letter l) may operate with 100% (one hundred percent) staff, only in the production/construction/services facilities to the public and for the office administration services to support operations, shall be enforced with a maximum of 25% (twenty five percent) staff;
- c) companies included in the sectors in letters d), e), f), g), h), k), and l) are required to use the *PeduliLindungi* application to conduct



- screening towards all employees and visitors who enter production/construction/service facilities and office administration areas; and
- d) companies that are included in the sector category according to letter c are required to obtain a recommendation from relevant ministries governing the technicality of that particular sector before gaining access to use the *PeduliLindungi* application;
- for supermarkets, hypermarkets, traditional markets, convenience stores and grocery stores that sell daily necessities, operating hours are limited until 21:00 local time with the visitor capacity of 50% (fifty percent);
- 5) for supermarkets and hypermarkets are required to use the *PeduliLindungi* application that has been started since September, 14th 2021; and
- 6) pharmacies and drugstores may be open for 24 hours,
  - d. public markets that sell non-daily necessities may operate with a maximum capacity of 50% (fifty percent) and operating hours until 17.00 local time;
  - e. street vendors, convenience stores, voucher agents/outlets, barbershops, laundry, hawkers, small repair shops, vehicle washes, and others oc its kind are allowed to open with strict health protocols until 21.00 local time, and technical regulations made by the Regional Government;
  - f. implementation of dining/drinking activities in public places:
    - food stalls/warteg, street vendors, hawker stalls, and others of its kind are allowed to open with strict health protocols until 21.00 local time with a maximum capacity of 50% (fifty percent) and a maximum of 60 (sixty) minutess of mealtime;
    - restaurants/diners, cafes that are located in buildings/shops or open spaces, in separate locations or in shopping centers/malls, may be allowed to open with the following conditions:
      - a) with strict health protocol up to 21.00 local time;
      - b) with a maximum capacity of 50% (fifty percent);
      - c) one table for a maximum of 2 (two) people;
      - d) maximum meal time of 60 (sixty) minutes;



- e) must use the *PeduliLindungi* application to conduct screening towards all visitors and employees,
- 3) restaurant/diners, cafes with operational hour that start at night may operate under the following conditions:
  - a) with strict health protocols and operating hours starting from 18.00 to a maximum of 00.00 local time;
  - b) with a maximum capacity of 25% (twenty five percent);
  - c) one table for a maximum of 2 (two) people;
  - d) maximum mealtime of 60 (sixty) minutes
  - e) must use the *PeduliLindungi* application to conduct screening towards all visitors and employees
- 4) technical arrangements number 1) to number 3) shall be regulated by the Regional Government,
  - g. activities in shopping centers/malls/trade centers may be open with the following conditions:
    - 1) maximum capacity of 50% (fifty percent) and operating hour until 21.00 local time by considering the provisions letter c.4 and letter f.2 by implementing the heath protocols regulated by the Ministry of Trade;
    - 2) must use *PeduliLindungi* application to screen all the visitors and employees of related shopping centers/malls/trade centers:
    - 3) residents under the age of 12 (twelve) years old are prohibited to enter the shopping centers/malls/trade centers, except in the Province of DKI Jakarta, City of Bandung, City of Yogyakarta, City of Surabaya with the condition that they are accompanied by their parents;
    - 4) children's playground and other public places located in the shopping centers/malls/trade centers are closed;
    - 5) Cinemas may oprate with the following conditions:
      - a) must use the *PeduliLindungi* application to conduct screening towards all visitors and employees;
      - b) maximum capacity of 50% (fifty percent) and only visitors with Green and Yellow categories in the *PeduliLindungi* application may enter;
      - c) visitors under the age of 12 (twelve) years are prohibited to enter;



- d) eating and drinking or selling food and beverages are prohibited in the area;
- e) following the health protocol regulated by the Ministry of Tourism and Economy Creative and Ministry of Health,
- h. implementation of construction activities for public infrastructure (construction sites and project sites) may operate 100% (one hundred percent) by implementing stricter health protocols;
- i. places of worship (Mosques, Prayer Rooms, Churches, Temples (*Pura*), Viharas and Temples (*Klenteng*) as well as other public places that function as places of worship) may hold congregational worship/religious activities during the implementation of Level 3 (three) PPKM with a maximum capacity of 50% (fifty percent) or 50 (fifty people) by implementing stricter health protocols by considering the technical requirements set forth by the Ministry of Religion;
- j. public facilities (public areas, public parks, public tourist attractions, and other public areas) are temporarily closed;
- k. health protocol trials will be carried out for certain tourist attractions with conditions as follows:
  - following the health protocol regulated by the Ministry of Tourism and Economy Creative, and the Ministry of Health;
  - 2) must use the *PeduliLindungi* application to conduct screening towards all visitors and employees;
  - 3) children under the age of 12 (twelve) years are prohibited to enter the tourist attraction that carried out this trial;
  - 4) list of tourist attractions that will take the trial is determined by the Ministry of Tourism and Creative Economy; and
  - 5) odd even policy along the way to and from the location of the tourist attraction starts from Friday 12.00 to Sunday 18.00 local time,
- I. arts, cultural, sports and social activities (locations of art, culture, sports facilities, and social activities that may cause crowds and masses) are temporarily closed, except for:



- sports activities are carried out in open spaces (outdoor) either individually or small group maximum of 4 (four) people, do not involve physical contact with other people and do not routinely require individual interactions at close range can implemented with the implementation of the protocol strict health. Sports activities in closed buildings, sport activities done in groups, and sport events are temporarily closed;
- outdoor sports facilities are allowed to open with the number of people 50% (fifty percent) of the maximum capacity;
- 3) masks must be used during sports activities, except for sport activities that require to removing of masks, such as swimming. For sport that require removing of masks, the mask shall only be removed when the sports activities are conducted;
- 4) temperature checks are carried out on everyone who enters the sports facilities;
- 5) restaurants/diners and cafes inside the sports facilities are permitted to accept dine-in with a maximum capacity of 50% (fifty percent) and maximum mealtime of 60 (sixty) minutes.
- 6) supporting facilities such as lockers, VIP rooms, and the bathrooms are not allowed to be used except for toilet access;
- 7) sports facilities users are not permitted to gather before and after doing sports activities and must keep their distance;
- 8) screening for visitors at the sports facility shall use the *PeduliLindungi* application; and
- 9) sports facilities that violate health protocols will be subjected to sanctions in the form of temporary closure,
- m. public transportations (public transport, mass transportation, taxis (conventional and online) and rental vehicles) shall be enforced with a maximum capacity arrangement of 70% (seventy percent) by applying stricter health protocols;



- n. wedding receptions are allowed with a maximum capacity of 20 (twenty) invitations and shall not accept dine-in by applying stricter health protocols;
- domestic travelers using private cars, motorcycles and longdistance public transport (airplanes, buses, ships, and trains) must:
  - 1) present their vaccination cards (minimum of the first dose of the vaccine);
  - present a (D-2) PCR results for airplanes, as well as (D-1) Antigen results, for private cars, motorcycles, buses, trains, and ships;
  - 3) the provisions referred to in number 1) and number 2) only apply for arrivals and departures to and from Java and Bali and do not apply to transportation within the agglomeration area for example for the Jabodetabek area;
  - 4) for travel by airplane between cities or districts within Java Bali shall present a negative Antigen result (D-1) if the second dose of vaccination has been obtained, and negative PCR result (D-2) if the first dose of the vaccine has been obtained; and
  - 5) for drivers of logistics vehicles and other transport of goods are excluded from the provision of having a vaccination card;
- wear masks correctly and consistently when carrying out activities outside the house and not allowed to use face shields without wearing masks; and
- q. implementation of PPKM Micro in Neighborhood Units or (Rukun Tetangga or "RT")/Community Units (Rukun Warga or "RW) Red Zones, shall remain in force by activating the Command Posts at every level by looking at the zoning criteria for regional control.

SIXTH

- : PPKM in Regencies and Cities in the region of Java and Bali with Level 2 (two) criteria as referred to to in the FIRST Dictum shall be carried out by implementing the following activities:
  - a. implementation of teaching and learning in the education units shall be conducted through limited face-to-face learning and/or distance



learning based on Joint Decree of the Ministry of Education and Culture, Ministry of Religion, Ministry Health and the Ministry of Home Affairs Number 03/KB/202I, Number 384 of 2021, Number HK.01.08/MENKES/4242/2021, Number 440-717 of 2021 on Guidelines on Implementation of Learning in the Coronavirus Disease 2019 (COVID-19) Pandemic and for educational units that carried out limited face-to-face learning implemented with a maximum capacity of 50% (fifty percent), unless for:

- 1) SDLB, MILB, SMPLB, SMALB, and MALB, with maximum 62% (sixty two percent) up to 100% (one hundred percent) by maintaining a minimum distance of 1.5m (one point five meters) and a maximum of 5 (five) students per class; and
- 2) PAUD, with maximum 33% (thirty three percent) by maintaining a minimum distance of 1.5 (one poinr five meters) and a maximum of 5 (five) students per class,
- b. implementation of activities in the non-essential sectors shall be enforced with 50% (fifty percent) Work From Office (WFO) for the employees who have been vaccinated and are required to use *PeduliLindungi* application on entrance and exit door of the workplace;
- c. implementation of activities in the sector of:
- 1) essential such as:
  - a) finance and banking, only include insurance, banks, pawn shops, futures exchange, pension funds, and financial institutions (oriented to physical service with the customers)
  - capital market (oriented to physical service with the customers and the capital market operations to run properly);
  - c) information and communication technology including cellular operator, data center, internet, media related to information dissemination to the public;
  - d) non-quarantine handling hotels; and
  - e) export-oriented industries and supporting industries where the company must present proof of the Export Declaration (*Pemberitahuan Ekspor Barang* or "**PEB**") document samples for the last 12 (twelve) months or other documents indicating an export plan and shall have an Industrial Activity Mobility and Operational Permit (*Izin Operasional dan Mobilitas Kegiatan*



*Industri* or "**IOMKI**") by taking into account the technical arrangements from the Ministry of Industry,

may operate with the following conditions:

- a) for letter a) may operate with a maximum capacity of 75% (seventy five percent) staff for locations related to services to the public as well as 50% (fifty percent) for the office administration services to support operations;
- b) for letter b) until letter c) may operate with a maximum capacity of 75% (seventy five percent) staff; and
- c) for letter d):
  - (1) must use *PeduliLindungi* application to conduct screening towards all employees and visitors:
  - (2) a maximum capacity of 50% (fifty percent) and only visitors with the Green and Yellow categories in the *PeduliLindungi* application may enter;
  - (3) facilities for fitness center/gym, lounge room/meeting room and meeting room with large capacity/ballroom may be allowed to open using *PeduliLindungi* application with a maximum capacity of 50% (fifty percent), as well as the provision of food and beverages at the lounge room/meeting rooms and meeting room with large capacity/ballroom served in a box and no dish buffet;
  - (4) visitors under the age of 12 (twelve) years must show a negative result of Antigen (Day-1)/PCR (Day-2),
- d) for letter e):
  - (1) can only operate with shift arrangement with a maximum capacity of 50% (fifty percent) of staff for each shift only in the production facilities/factories;
  - (2) 10% (ten percent) office administration services to support operations;
  - (3) number (1) (one) and number (2) (two) are carried out with implementation of Health protocols; and
  - (4) must use the *PeduliLindungi* application regulating the entrance and exit; and
  - (5) employees shall not have meals at the same time.
- 2) essential in the government sector shall follow technical provisions issued by Ministry of State and Bureaucratic Reform.
- 3) critical such as:

- a) health;
- b) security and order;
- c) disaster management;
- d) energy;
- e) logistics, postal, transportation, and distribution especially for the public's basic needs;
- f) food and beverage and its supporting industries, including for livestock and pets;
- g) fertilizer and petrochemicals;
- h) cement and building materials;
- i) national vital objects;
- j) national strategic projects;
- k) construction (public infrastructure including telecommunications and broadcasting infrastructure);
- I) basic utilities (electricity, water, and waste management); may be operated with the following conditions:
- a) for letter a) and letter b) may operate with 100% (one hundred percent) staff without any exception; and
- b) for letter c) until letter l) may operate with 100% (one hundred percent) staff, only in the production/construction/services facilities to the public and for the office administration services to support operations, shall be enforced with a maximum of 50% (fifty percent) staff;
- c) companies included in the sector in letter d), e), f), g), h), k), and 1) are required to use *PeduliLindungi* application that has been started since September 7, 2021 to conduct screening towards all employees and visitors who enter production/construction/services and office administration services and areas; and
- d) companies that are included in the sector category according to letter c) are required to obtain a recommendation from relevant Ministries governing the technicality of that particular sector before gaining access to use the *PeduliLindungi* application,
- 4) for supermarkets, hypermarkets, traditional markets, convenience stores and grocery stores that sell daily necessities, operating hours are limited until 21:00 local time with the visitor capacity of 75% (seventy five percent);



- 5) for supermarkets and hypermarkets are required to use the *PeduliLindungi* application that has been started since September 14, 2021; and
- 6) pharmacies and drugstores may be open for 24 (twenty four) hours,
- d. public markets that sell non-daily necessities may operate with a maximum capacity of 75% (seventy five percent) and the operating hours until 18.00 local time;
- e. street vendors, convenience stores, voucher outlets/agents, barbershops, laundry, hawkers, small repair shops, vehicle washes, and others of its kind are allowed to open with strict health protocols until 21.00 local time with the technical regulations made by the Regional Government;
- f. implementation of dining/drinking activities in public places:
  - food stalls/warteg, street vendors, hawker stalls, and others of its kind are allowed to open with strict health protocols until 21.00 local time with a maximum visitors of 50% (fifty percent) and a maximum of 60 (sixty) minutess of mealtime which the tecnical regulations are made by the Regional Government;
  - 2) restaurants/diners, cafes that are located in buildings/shops or open area, in separate locations in shopping centers/malls, may be allowed to open with the following conditions:
    - a) with strict health protocol up to 21.00 local time;
    - b) with a maximum capacity of 50% (fifty percent);
    - c) maximum meal time of 60 (sixty) minutes; must use the *PeduliLindungi* application to conduct screening towards all visitors and employees,
  - 3) restaurant/diners, cafes with operating hours starting at night may operate under the following conditions:
    - a) with strict health protocols and operating hours starting from 18.00 to a maximum of 00.00 local time;
    - b) with a maximum capacity of 50% (fifty percent);
    - c) maximum mealtime of 60 (sixty) minutes
    - d) must use the *PeduliLindungi* application to conduct screening towards all visitors and employees,
  - 4) technical arrangements number 1) to number 3) are regulated by the Regional Government,

- g. activities in shopping centers/malls/trade centers may be open with a maximum capacity of 50% (fifty percent) until 21.00 local time by considering the provisions of letter c.4) and letter f.2) and required to use the *PeduliLindungi* application;
- h. Cinemas may operate with the following conditions:
  - 1) must use the *PeduliLindungi* application to conduct screening towards all visitors and employees;
  - 2) maximum capacity of 50% (fifty percent) and only visitors with Green and Yellow categories in the *PeduliLindungi* application may enter:
  - 3) visitors under the age of 12 (twelve) years are prohibited to enter; and
  - 4) eating and drinking or selling food and beverages are prohibited in the area;
  - 5) following the health protocol regulated by the Ministry of Tourism and Economy Creative and Ministry of Health,
- i. implementation of construction activities for public infrastructure (construction sites and project sites) may operate 100% (one hundred percent) by implementing stricter health protocols;
- j. places of worship (Mosques, Prayer Rooms, Churches, Temples (*Pura*), Viharas and Temples (*Klenteng*) as well as other public places that function as places of worship) may hold congregational worship/religious activities during the implementation of Level 2 (two) PPKM with a maximum capacity of 75% (seventy five percent) or 75 (seventy five) people by implementing stricter health protocols by considering the technical requirements set forth by the Ministry of Religion;
- k. public facilities (public areas, public parks, public tourist attractions, and other public areas) may be open with a maximum capacity of 25% (twenty five percent) by implementing:
  - 1) following the health protocol regulated by the Ministry of Health and/or related ministries/agencies;
  - 2) must use the *PeduliLindungi* application to conduct screening towards all visitors and employees;
  - 3) children under the age of 12 (twelve) years are prohibited to enter; and



- 4) odd even policy along the way to and from the location of the tourist attraction starts from Friday 12.00 to Sunday 18.00 local time.
- arts, cultural, sports and social activities (locations of art, culture, sports facilities, and social activities that may cause crowds and masses) may be open with a maximum capacity of 50% (fifty percent) by implementing stricter health protocols and required to use the *PeduliLindungi* application;
- m. public transportations (public transport, mass transportation, taxis (conventional and online) and rental vehicles) shall be enforced with a maximum capacity arrangement of 100% (one hundred percent) by applying stricter health protocols;
- n. wedding receptions are allowed with a maximum capacity of 50 (fifty) invitations and shall not accept dine-in;
- o. domestic travelers using private cars, motorcycles and longdistance public transport (airplanes, buses, ships, and trains) must:
  - present their vaccination cards (minimum of the first dose of the vaccine);
  - present a (D-2) PCR results for airplanes, as well as (D-1)
     Antigen results, for private cars, motorcycles, buses, trains, and ships;
  - 3) the provisions referred to in number 1) and number 2) only apply for arrivals and departures to and from Java and Bali and do not apply to transportation within the agglomeration area for example for the Jabodetabek area;
  - 4) for traveling by airplane between city or regency within Java Bali shall present a negative Antigen result (D-1) if the second dose of vaccination has been obtained, and negative PCR result (D-2) if the the first dose of the vaccination has been obtained; and
  - 5) for drivers of logistics vehicles and other transport of goods are excluded from the provision of having a vaccination card;
- wear masks correctly and consistently when carrying out activities outside the house and are not allowed to use face shields without wearing masks; and
- q. implementation of PPKM in Neighborhood Units/Community Units, Village/Regency and Sub-District shall remain in force by activating



the Commands at every level by looking at the zoning criteria for regional control.

#### SEVENTH

Industries with export and domestic orientation in level 4 (four), level 3 (three), and level 2 (two) are allowed to operate with a capacity of 100% (one hundred percent) of staff divided minimum in 2 (two) shifts with the provisions as follows:

- a. have IOMKI and get recommendations from the Ministry of Industry;
- companies listed and its employees are required to use *PeduliLindungi* application to conduct screening towards people who exit and enter the company production facilities;
- c. at least 50% (fifty percent) of employees has been vaccinated with a dose (one) vaccine;
- d. all companies are required to follow the health protocol reference as stipulated by the Ministry of Industry and Ministry of Health; and
- e. Ministry of Industry and staff of local government shall supervise over the implementation of the health protocol.

## EIGHTH

League 1 (one) Soccer Competition 1 may be carried out with a maximum of 9 (nine) matches and League 2 (two) Soccer Competition 2 (may be carried out with a maximum of 8 (eight) matches every week, with the following conditions:

- 1) the venue is only in the region of Regencies/Cities with level 3 (three) and level 2 (two) criteria;
- 2) all players, officials, media crew and support staff are required to use PeduliLindungi application to conduct screening towards people who come in and out of the competition and training venues.
- Implementation of the competition shall not have live spectators in the stadium. The activity of watching the competitions together by supporters is also not allowed;
- 4) all prayers, officials, media crew and support staff who attend the competition must have already received the second dose of vaccination, and (D-1) negative PCR result and negative Antigen result on the competition day; and
- 5) the implementation of league 1 (one) competition is required to follow the health protocol rules determined by the Ministry of Health and Indonesian Football Association.

## NINTH

Restrictions on the entrance of international passenger travel are regulated with the following conditions:



- a) air entry only through the Soekarno Hatta Airport and Sam Ratulangi Airport;
- b) sea entry only through ports of Batam, Tanjung Pinang, and Nunukan;
- c) land entry only through the Postal Cross State Boundary (*Pos Lintang Batas Negara or "PLBN"*) of Aruk and Entikong, and Motaain; and
- d) technical arrangements related to implementation of the provisions as referred to in letter a) until letter c) and in the transition period will be regulated further by the Ministry of Transportation.

TENTH : Governor after receiving vaccine supply from the Ministry of Health, shall

immediately distribute it to the Regency/City and do not keep it as a

reserve (stock) in the Province.

ELEVENTH : Governors, Regents, and Mayors shall prohibit any form of

activities/actions that can cause crowds.

TWELVE : Governors, Regents and Mayors shall coordinate and collaborate with the

National Army of Indonesia, the National Police of Republic of Indonesia

and the Attorney in the implementation of PPKM.

THIRTEENTH: Implementing the tightening of activities and education with the following principles:

- a. COVID-19 is most contagious in closed conditions, long meetings (more than 15 minutes), close interactions, crowds, activities with strong breathing such as singing, laughing, and not wearing masks such as when eating together;
- b. proper and consistent use of masks is the minimum health protocol that should be implemented by everyone;
- washing hands with soap or hand sanitizer repeatedly especially after touching objects that others touch (such as door handles or handrails), touching the face area by hand should be avoided;
- d. an ideal type of mask will be more protective the use of masks as many as 2 (two) layers is a good choice. Masks should be replaced after use (>4 (more than four) hours);
- e. the implementation of health protocols shall be carried out by taking into account the factors of air ventilation, duration, and distance of interaction, to minimize the risk of transmission in conducting activities;
- f. considerations on distance can be applied as follows:
  - carry out activities from home, and interact only with people who live in the same household;



- 2) If there is a necessity to leave the house, always try to get a minimum distance of 2 (two) meters in interacting with others. Reduce/avoid contact with others who do not live in the same household; and
- 3) socialize various visual instructions in public places related to the prevention and handling of COVID-19,
- g. considerations on duration can be applied as follows:
  - if there is a necessity to interact with other people or attend an activity, it must be done in a short duration to reduce the risk of transmission; and
  - 2) in office environments and other activities, scheduling and rotation may help in decreasing the duration of interaction,
- h. considerations on ventilation can be applied as follows:
  - 1) outdoor activities that have lower transmission risk compared to the indoor ones; and
  - 2) rooms shall always be endeavored to have good air ventilation. Opening doors, windows may be done to decrease the transmission risk. In the event that the door and the window cannot be opened, an air purifier with High-Efficiency Particulate Air (HEPA) filter may be utilized indoor,
- i. in the event that the transmission condition has been spread in the community, tightened intervention by significantly limiting the public's mobility is needed;
- j. intensifying of 3T (testing, tracing, treatment) shall always be implemented:
  - testing shall be intensified according to the weekly positivity rate with the following provisions.

Testing shall always be intensified with the target of positivity rate of <5% (five percent). Target of the daily testing is the minimum number



of daily test which must be met by the regencies/cities. People who are counted in target testing are suspects and the contacts of confirmed cases, not people with asymptomatic screening. Daily target of the number of people tested must be achieved at the level districts/cities with the following table;

- 2) tracing should be carried out until there are more than 15 close contacts per confirmed case. Quarantine shall be carried out for those identified as close contacts. Once identified, close contacts should be checked (entry test) and quarantine needs to be carried out. If the test result is positive then isolation is necessary. If the test result is negative, then quarantine must be continued. On the 5th day of quarantine, it is necessary to re-examine (exit-test) to see whether the virus is detected after/during the incubation period. If negative, the patient is considered to have completed the quarantine; and
- 3) treatment shall be comprehensively carried out according to the severity of the symptoms. Only patients with moderate, severe, and critical symptoms need be treated in the hospital. Isolation shall be carried out strictly to prevent transmissions, efforts to accelerate vaccination must continue to be carried out to protect as many people and these efforts are carried out to lower the rate of transmission and prioritize the safety of those who are vulnerable to mortality (such as elderly, people with comorbidities), noting the limited health capacity and long-term impact of COVID-19 infection.

Governors, Mayors, and Regents to:

Н

- a. accelerate social aid distribution process as well as social safety net provided from the Regional Revenues and Expenditures Budget (Anggaran Pembelanjaan dan Belanja Daerah or "APBD"), if there is a need for additional funding for budgeting and distribution of social aid and social safety net in support of the implementation of COVID-19 PPKM, then:
  - rationalization and/or reallocation of budgets from less priority programs/activities in the social assistance budget and social safety nets;
  - 2) the procedure for rationalization and/or reallocation of additional funding needs for budgeting and distribution of social aid/social safety nets in supporting the implementation of COVID-19 PPKM shall be guided by Article 4 and Article 5 of Regulation of the Minister of Home Affairs Number 20 of 2020 regarding the Acceleration of Handling of Corona Virus Disease 2019 in the Regional Government Environment and Article 3 to Article 6 of



the Minister of Home Affairs Regulation Number 39 of 2020 regarding Prioritizing the Use of Budget Allocations for Certain Activities, Amendment in Allocation and Use of Regional Revenue and Expenditure Budgets;

- 3) on the acceleration of the distribution and implementation of Village Fund Direct Cash Assistance (*Bantuan Langsung Tunai Dana Desa* or "**BLT-DD**"):
  - a) Regents/Mayors to accelerate the evaluation of Village Revenue and Expenditure Budget (Anggaran Pendapatan dan Belanja Desa or "APBDesa") for Villages that have not stipulated Village Regulations regarding APBDesa, ratification of Human Development Cadre (Kader Pembangunan Manusia or "KPM") data by the Regional government, recording of KPM Data of BLT-DD recipients on State Budget Treasury System Online Monitoring (Online Monitoring Sistem Perbendaharaan Anggaran Negara or "Om-SPAN") in accordance with the provisions of the laws and regulations; and
  - Village Head to conduct recording and stipulation of KPM, and follow up with the implementation of BLT-DD in accordance with the provisions of laws and regulations,

to conduct social aid synchronization sourced from the center and social aid sourced from APBD.

#### FIFTEENTH

Funding for the Implementation of PPKM due to the COVID-19 Pandemic sourced from APBD:

- a. in the implementation of COVID-19 PPKM due to the COVID-19 Pandemic, the Regional Government can make expenditures for which the budget is not yet available, which is then proposed in the draft APBD amendment:
- the expenditure as referred to in letter a is carried out with a direct charge to the Unexpected Expenditure (*Belanja Tidak Terduga* or "BTT");
- c. in the event that BTT is insufficient, the Regional Government shall rescheduling of program and activity achievements to prioritize the use of budget allocations for certain activities and/or amendments in budget allocations and utilizes available cash through amendment to regional head regulations concerning APBD, and notifies the chair of



- the Regional House of Representatives. The results of the budget allocation for rescheduling the results of the program and activity achievements are diverted for unexpected expenditures; and
- d. the procedure for using BTT in the context of implementing PPKM due to the COVID-19 Pandemic originating from the APBD shall be guided by the Minister of Home Affairs Regulation Number 39 of 2020.

#### SIXTEENTH

- In the event that the Governors, Mayors, or Regents do not implement the provisions as referred to in this Ministerial Instruction shall be subject to sanctions as referred to in Article 68 until Article 78 of Law Number 23 of 2014 regarding Regional Government;
- b. For Restaurant, Shopping Centers, and Public Transportation Business Actors as referred to in the THIRD Dictum letter c, letter d, letter e, and letter i that do not implement the provisions as regulated in this Instruction shall be subject to administrative sanctions until the closure of business in accordance with the provisions of the laws and regulations; and
- Every person may be imposed with sanctions for violations in the framework of controlling infectious disease outbreaks according to:
  - Article 212 to Article 218 of Indonesian Criminal Code; 1)
  - Law Number 4 of 1984 regarding Outbreaks of Infectious 2) Diseases:
  - 3) Law Number 6 of 2018 regarding Health Quarantine; and
  - 4) Regional Regulation, Regional Head Regulation; as well as
  - Provisions of other relevant laws and regulations. 5)
