SE 62 YEAR 2021 REGARDING GUIDELINES ON THE IMPLEMENTATION OF THE  
DOMESTIC TRAVEL OF PERSONS BY AIR TRANSPORTATION DURING THE CORONA  
VIRUS DISEASE 2019 (COVID-19) PANDEMIC

1. Background

In relation to the stipulation of the Addendum to the Circular Letter of the Head of Task Force for Handling of COVID-19 Number 17 of 2021 regarding Provisions of the Domestic Travel of Persons by Air Transportation During the Corona Virus Disease 2019 (COVID-19) Pandemic, it is necessary to stipulate an amendment to the Circular Letter of the Minister of Transportation Number SE 62 of 2021 Regarding Guidelines on the Implementation of the Domestic Travel of Persons by Air Transportation during The Corona Virus Disease 2019 (COVID-19) Pandemic.

2. Objectives and purposes
  - a. To Implement stricter health protocols for travelers using modes of domestic air transportation during the Corona Virus Disease 2019 (COVID-19) pandemic;
  - b. To prevent the spread and increase of Corona Virus Disease 2019 (COVID-19) transmission;
  - c. To break the chain of Corona Virus Disease 2019 (COVID-19) transmission by limiting travel of persons by air transportation during The Corona Virus Disease 2019 (COVID-19) Pandemic; and
  - d. To Implement the use of the *PeduliLindungi* application in examination of traveler's health requirements.
  
3. The scope of this Circular Letter includes:
  - a. The Public Health Protocols for modes of air transportation;
  - b. The Health Protocols for Domestic Travel Actors for modes of air transportation;
  - c. The terms of use of the *PeduliLindungi* application; and
  - d. The Monitoring, Control and Evaluation

  - b. Law Number 6 of 2018 regarding Health Quarantine;

5. Contents of Circular
- Adding provisions for the domestic travel of persons by air transportation in number 5 letter a point 1) of Circular Letter of the Minister of Transportation Number SE 62 Year 2021 Regarding Guidelines on the Implementation of the Domestic Travel of Persons by Air Transportation during the Corona Virus Disease 2019 (Covid-19) Pandemic, by adding points i) and j) as follows:

a. Guidelines for the implementation of domestic travel of persons by air transportation during the Corona Virus Disease 2019 (COVID-19) Pandemic, as follows:

1) Provisions for Domestic Persons/Passengers who are using air transportation must fulfill the following provisions:

i) travelers of Persons/Passengers must use the *PeduliLindungi* application as a condition for domestic travel to check the results of the RT-PCR test or rapid antigen test which results are negative and have carried out the first dose or the complete dose vaccination.

6. Closing

The Circular Letter shall be effective as of September 7, 2021 and can be amended and corrected at any time in accordance with the instructions/notifications from the authorized institutions.
