## CIRCULAR LETTER NUMBER SE 73 OF 2021

## REGARDING

SECOND AMENDMENT TO THE CIRCULAR LETTER OF THE MINISTER OF TRANSPORTATION NUMBER SE 56 OF 2021 REGARDING GUIDELINES ON THE IMPLEMENTATION OF THE DOMESTIC TRAVEL OF PERSONS BY LAND TRANSPORTATION DURING THE CORONA VIRUS DISEASE 2019 (COVID-19) PANDEMIC

1. Background

In light of the stipulation of the Addendum of the COVID-19 Handling Task Force Circular Letter Number 17 of 2021 regarding Provisions for Domestic Travel of



Persons During the Corona Virus Disease 2019 (COVID-19) Pandemic, it is deemed necessary to stipulate Instruction for the Implementation of Domestic Travel of Persons by Land Transportation During the Corona Virus Disease 2019 (COVID-19) Pandemic.

- 2. Objectives and purposes:
  - a. to increase the implementation of stricter health protocols for travelers using modes of land transportation during the Corona Virus Disease 2019 (COVID-19) pandemic;
  - b. to impose restrictions on domestic travellers using modes of land transportation to prevent the spread and increase of Corona Virus Disease 2019 (COVID-19) transmission;
  - c. to prevent the increase of the Corona Virus Disease 2019 (COVID-19) transmission, including the new SARS-CoV-2 virus variant which has mutated into the Alpha variant, Beta variant, Delta variant, Gamma variant and MU variant (B.1.621) as well as the potential for the development of another new SARS-Co-2 variant; and
  - d. monitoring, controlling, and evaluating the Corona Virus Disease 2019 (COVID-19) using the *PeduliLindung* application.
- 3. The scope of this Circular Letter shall include:
  - a. public health protocols on modes of land transportation;
  - b. health protocols for domestic travelers for land transportation;
  - c. terms of use of the PeduliLindungi application; and
  - d. monitoring, control and evaluation.
- 4. Legal Basis:
  - a. Law Number 17 of 2008 regarding Shipping;
  - b. Law Number 22 of 2009 regarding Road Traffic and Transportation;



- c. Law Number 6 of 2018 regarding Health Quarantine;
- d. Government Regulation Number 21 of 2020 regarding Large-Scale Social Restrictions for Accelerating the Handling of Corona Virus Disease 2019 (COVID-19);
- e. Presidential Regulation Number 82 of 2020 regarding the Committee for Handling Corona Virus Disease 2019 (COVID-19) and National Economic Recovery;
- f. Presidential Decree Number 11 of 2020 regarding Stipulation of Public Health Emergency of the Corona Virus Disease 2019 (COVID-19);
- g. Presidential Decree Number 12 of 2020 regarding Stipulation of Non-Natural Disaster of the Spread of Corona Virus Disease 2019 (COVID-19) as National Disasters;
- Regulation of the Minister of Health Number 9 of 2020 regarding Guidelines for Large-Scale Social Restrictions to Accelerate Mitigation of Corona Virus Disease 2019 (COVID-19);
- Regulation of the Minister of Transportation Number PM 18 of 2020 regarding Transportation Control for the Purpose of Preventing the Spread of Corona Virus Disease 2019 (COVID-19), as amended by Regulation of Minister of Transportation Number PM 41 of 2020;
- Instruction of the Minister of Home Affairs Number 39 of 2021 regarding the Implementation of Level 4, Level 3, and Level 2 Corona Virus Disease 2019 Restrictions on Public Activities in the Java and Bali Regions;
- Instruction of the Minister of Home Affairs Number 40 of 2021 regarding Implementation of Level 4 Corona Virus Disease 2019 Restrictions on Public Activities in the Sumatra, Kalimantan, Sulawesi, Nusa Tenggara, and Papua Regions;
- Instruction of the Minister of Home Affairs Number 41 of 2021 regarding Implementation of Level 3, Level 2 and Level 1 Restrictions on Public Activities and Optimizing the Command Post for Handling Corona Virus Disease 2019 at



the Village and Sub-District Levels for Controlling the Spread of Corona Virus Disease 2019;

- m. Addendum to the Circular Letter of COVID-19 Handling Task Force Number 17 of 2021 regarding Provisions for Domestic Travel During the Corona Virus Disease 2019 (COVID-19) Pandemic; and
- n. Decision of the Ministerial Level Limited Coordination Meeting on August 31, 2021.
- 5. Contents of Circular

Several provisions in the Circular Letter of the Minister of Transportation Number SE 56 of 2021 regarding Guidelines on the Implementation of Domestic Travel of Persons by Land Transportation During the Corona Virus Disease 2019 (COVID-19) Pandemic, shall be amended as follows:

- a. The provisions as set out in Number 5 letter c.3) shall be amended as follows:
  3) particularly for routine trips by modes of land transportation using individual motorized vehicles, public motorized vehicles, river, lake, and crossing transportation, within one city agglomeration region/area with the following provisions:
  - a) are not required to show a vaccine card and a certificate of negative results for the RT-PCR or Rapid Antigen Test. For travel actors in one city agglomeration area, random tests can be conducted (random check);
  - b) are **not** required to be accompanied by the following document requirements:
    - (1) Worker Registration Certificate (*Surat Tanda Registrasi Pekerja*) or other Certificate issued by the local Regional Government; and/or
    - (2) duty sertificate *(surat tugas)* signed by the company management of officials of a minimum echelon 2 (for government) and wet stamp/stamped or electronic signature.
- b. adding the provisions in number 5 (five), namely between the letters d and e, by adding 3 (three) new provisions, namely the letters d.1), d.2), and d.3), as follows:

- d.1) every domestic travel actors of persons using land transportation during the Corona Virus Disease 2019 (COVID-19) pandemic is required to use the *PeduliLindung* application as a condition for traveling domestically;
- d.2) every manager/operator of modes of land transportation is required to use the *PeduliLindungi* application to check the results of the RT-PCR or Antigen Swab test in which results shall be negative and have carried out the first dose or complete dose of vaccination for every domestic travel actors of persons during check-in;
- d.3) use of *Pedulilindungi* application as referred to in d.1) and d.2) with the following provisions:
  - carried out in stages and prioritized for domestic travel actors of persons using public motorized vehicles as well as river, lake and crossing transportation;
  - 2) for domestic travel actors of persons who do not have a smartphone supporting the *Pedulilindungi* application, they can show:
    - a) ID Number (Nomor Induk Kependudukan/NIK); or
    - b) physical evidence of a negative RT-PCR test result or a negative Rapid Test Antigen result and a vaccine card (a minimum of the first dose of vaccine).
- c. Ministers, Governors, Regents/Mayors, Central and Regional Corona Virus Disease 2019 (COVID-19) Handling Task Forces, technical implementing units within the Directorate General of Land Transportation, and organizers/operators of land transportation infrastructure shall coordinate, socialize, and supervise the implementation of this Circular Letter.
- d. This Circular Letter shall be effective as of September 7, 2021 until a later date is determined and can be extended according to the needs and/or the latest developments in the field.



6. Closing

This Circular Letter can be amended and corrected at any time in accordance with the instructions/notifications from the authorized institutions.
