**CIRCULAR LETTER
NUMBER IMI-0700.GR.01.01 OF 2022**

REGARDING

**EASE OF IMMIGRATION IN ORDER TO SUPPORT SUSTAINABLE
TOURISM DURING THE CORONA VIRUS DISEASE 2019 PANDEMIC**

1. Introduction

- a. Whereas to optimize the functions of immigration as a facilitator to the development of public welfare and to support government policies of reopening the tourism sector more broadly with the concept of sustainable tourism, it is necessary to provide the ease of immigration based on the principle of reciprocity and the principle of benefit in the form of granting visa-free visits and limited visit visa on arrival for certain foreigners;
- b. Whereas based on the direction of the President of the Republic of Indonesia, immigration instruments hold an important role in increasing investment and the national economy so it is necessary to expand the activities that certain foreigners can carry out to conduct business and meetings;
- c. Whereas based on the results of the evaluation, it is deemed necessary to adjust several provisions in Circular Letter of the Director General of Immigration Number IMI-0650.GR.01.01 of 2022 regarding the Ease of Immigration in Order to Support Sustainable Tourism During The Corona Virus Disease 2019 Pandemic by adding Albania, Andorra, Chile, Ecuador, Iceland, Liechtenstein, Palestine, San Marino, Suriname, Uzbekistan, and the Vatican into the list of Countries, Governments of a Special Administrative Region of a Country, and Certain Entities whose citizens are granted with the ease of immigration in the form of a visit visa on arrival for tourism only and make adjustments to the list of Immigration Checkpoints for Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) and Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*);
- d. Whereas based on the considerations as referred to in letter a, letter b, and letter c, it is necessary to issue a Circular Letter of the Director General of Immigration regarding the Ease of Immigration in Order to Support Sustainable Tourism During the Corona Virus Disease 2019 Pandemic.

2. Purpose and objective

- a. The purpose of issuing this circular letter is to optimize the support of immigration in opening the tourism sector during the Corona Virus Disease 2019 pandemic;
- b. The objective of issuing this circular letter is to monitor, control and evaluate the implementation of the Ease of Immigration in Order to Support Sustainable Tourism During the Corona Virus Disease 2019 Pandemic.

3. Scope

The scope of this Circular Letter is the affirmation of the functions of immigration in supporting the reopening of the tourism sector During the Corona Virus Disease 2019 Pandemic.

4. Basis

- a. Law Number 6 of 2011 regarding Immigration;
- b. Law Number 11 of 2020 regarding Job Creation;
- c. Government Regulation Number 31 of 2013 regarding the Implementing Regulation of Law Number 6 of 2011 regarding Immigration as amended several times, lastly amended by Government Regulation Number 48 of 2021 regarding the Third Amendment of Government Regulation Number 31 of 2013 regarding Implementing Regulation of Law Number 6 of 2011 regarding Immigration;
- d. Presidential Decree Number 24 of 2021 regarding the Stipulation of the Factual Status of the Corona Virus Disease 2019 (Covid-19) Pandemic in Indonesia;
- e. Minister of Law and Human Rights Regulation Number 44 of 2015 regarding the Procedure to Examine the Entrance and Departure to and from the Indonesian Territory at the Immigration Checkpoints;
- f. Minister of Law and Human Rights Regulation Number 28 of 2018 regarding Immigration Stamp;
- g. Minister of Law and Human Rights Regulation Number 29 of 2021 regarding Visa and Stay Permit;
- h. Minister of Law and Human Rights Regulation Number 34 of 2021 regarding the Granting of Visa and Immigration Stay Permit in the Period of Handling the Spread of the Corona Virus Disease 2019 and National Economic Recovery;
- i. Minister of Law and Human Rights Regulation Number 41 of 2021 regarding the Organization and the Working Procedure of the Ministry of Law and Human Rights;
- j. Circular Letter of the Head of the Covid-19 Handling Task Force Number 25 of 2022 regarding Health Protocols for Overseas Travel During the Corona Virus Disease 2019 (COVID-19) Pandemic;
- k. Result of Decision from the Limited Cabinet Meeting of September 09, 2022.

5. Contents of the Circular Letter

a. General:

To ensure that all officials and service officers:

- 1) Provide excellent service towards the community;
- 2) Do not conduct acts of Corruption, Collusion, and Nepotism;

- 3) Conduct a step-by-step supervision; and
 - 4) Conduct coordination and socialization with stakeholders and immigration guarantors related to this Circular Letter;
- b. Head of the Immigration Division of the Regional Office of the Ministry of Law and Human Rights:
- 1) Conduct development, management, supervision, and evaluation of the implementation of the policy regarding Ease of Immigration in Order to Support Sustainable Tourism During the Corona Virus Disease 2019 Pandemic,
 - 2) Submit an evaluation result on the implementation of the policy periodically every 7 (seven) days to the Director General of Immigration;
- c. Head of Immigration Office:
- 1) Disseminate information towards stakeholders and the general public as well as carry out the necessary coordination regarding the Ease of Immigration in Order to Support Sustainable Tourism During the Corona Virus Disease 2019 Pandemic policy;
 - 2) Ensure that owners or managers of an accommodation facility in their working area provide information or data regarding foreigners who are staying at their home or accommodation facility;
 - 3) Impose sanctions towards owners or managers of accommodation facilities who fails to provide information or fails to provide data regarding foreigners who are staying at their home or accommodation facility in accordance with the provisions of laws and regulations;
 - 4) Impose sanctions towards foreigners holding a Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) and Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) who conduct activities that do not conform with the purposes and objectives of the granted Stay Permit;
 - 5) Impose sanctions towards foreigners who are proven to have conducted a violation in accordance with the provisions of the laws and regulations regarding immigration and/or have violated public order during the implementation of health protocols;
 - 6) The imposition of sanctions towards foreigners who have violated public order during the implementation of health protocols as referred to in number 5) is conducted after receiving recommendation from agencies responsible for the handling/control of Covid-19;
 - 7) Extend the Immigration Stay Permit derived from the Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*);
 - 8) Control the implementation of immigration inspection activities at Immigration Checkpoints and/or immigration control;
 - 9) Report the implementation of activities periodically to the Head of Immigration Division.
- d. Head of Immigration Office in charge of Immigration Checkpoint determined by Head of the Covid-19 Task Force as the entrance to the arrival of Indonesian citizens and foreigners:
- 1) Ensure that the implementation of immigration checks in the Immigration Area which includes bank counters, immigration counters in the arrival area, and immigration counters in the departure area can fulfill the provisions of laws and regulations;
 - 2) Ensure that the Person in Charge of Transportation Means carries out obligations in accordance with the provisions of laws and regulations in the field of immigration;

- 3) Conduct immigration inspections towards Indonesian citizens, transportation crews, foreigners holding a Diplomatic Passports or Service Passports who are granted Diplomatic Visa-Free or Service Visa-Free facilities, foreigners holding Visa or Stay Permit, and foreigners holding APEC Business Travel Card (*Kartu Perjalanan Perbisnis APEC* or *KPP APEC*) in accordance with the provisions of laws and regulations;
- 4) Visa or Stay Permit as referred to in number 3) consists of:
 - a) Diplomatic Visa,
 - b) Service Visa,
 - c) Visit Visa,
 - d) Limited Stay Visa,
 - e) Diplomatic Stay Permit,
 - f) Service Stay Permit,
 - g) Permanent Stay Permit, or
 - h) Limited Stay Permit,
- 5) Refuse entry towards foreigners and providing Exit Mark in accordance with the provisions of laws and regulations.

e. Head of Immigration Office as stated in Appendix I and Appendix II of this circular letter:

- 1) Instruct the Administrative Officer in charge of immigration inspections at the Immigration Checkpoints to:
 - a) Grant a Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) at Immigration Checkpoints as stated in Appendix I of this circular;
 - b) Grant a Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) at Immigration Checkpoints as stated in Appendix II of this circular;
 - c) The granting of Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) as referred in letter a) is carried out through immigration inspections in accordance with Article 23 paragraph (1) and paragraph (2) of the Minister of Law and Human Rights Regulation Number 44 of 2015 regarding the Procedure to Examine the Entrance and Departure of Indonesian Territory at the Immigration Checkpoints for foreigners who are citizens of a Country, Governments of Special Administrative Region of a Country, and Certain Entities as the Subject of the Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*);
 - d) The Entry Mark in the granting of a Visit Visa Exemption for Tourism refers to the Entry Mark and Stay Permit of the visit visa exemption subject in the Minister of Law and Human Rights Regulation Number 28 of 2018 regarding Immigration Stamp which acts as a Visit Stay Permit with a maximum period of 30 (thirty) days and cannot be extended;
 - e) Countries, Governments of Special Administrative Region of a Country, and Certain Entities as the Subject of the Visit Visa-Free Specifically for Tourism are:

(1) Brunei Darussalam,	(6) Myanmar,
(2) Philippines,	(7) Singapore,
(3) Cambodia,	(8) Thailand, and
(4) Laos,	(9) Vietnam,
(5) Malaysia,	
 - f) The granting of Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat*

Kedatangan Khusus Wisata) as referred in letter b) is carried out through immigration inspections in accordance with Article 23 and Article 26 letter b of the Minister of Law and Human Rights Regulation Number 44 of 2015 towards foreigners who are citizens of a Country, Governments of Special Administrative Region of a Country, and Certain Entities as the Subject of the Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*);

- g) The Entry Mark in the granting of a Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) refers to the Entry Mark and Stay Permit of the visit visa on arrival holder in the Minister of Law and Human Rights Regulation Number 28 of 2018 which act as a Visit Stay Permit with a maximum period of 30 (thirty) days which can be extended for a maximum of 1 (one) time extension for a period of 30 (thirty) days at the Immigration Office which working area includes the residence of foreigners and cannot be transferred;
- h) Countries, Governments of Special Administrative Region of a Country, and Certain Entities as the Subject of the Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) are:

- i) The granting of the Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) and the Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) is carried out by checking the following requirements:
- (1) Nationality Passport including:
 - (a) Diplomatic Passport,
 - (b) Service Passport, or
 - (c) Regular Passport/General Passport,which is valid and still effective for at least 6 (six) months,
 - (2) Return ticket or transit ticket to carry out the journey to another country, and
 - (3) Proof of payment of Non-Tax State Revenues (*Penerimaan Negara Bukan Pajak* or PNBP) for visit visa on arrival, in case of a submission for a Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*),
- j) The Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) and Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) can be used by foreigners to carry out the following activities:
- (1) Tourist visit;
 - (2) Government duty visits;
 - (3) Business talk visits;
 - (4) Purchase of goods visits;
 - (5) Meeting visits; or
 - (6) Transits.
- k) Description of activities as referred to in letter j) refers to the Appendix to Ministry of Law and Human Rights Decree regarding Types of Activities for Foreigners in the Framework of the Granting of Visa During the Handling Period for the Spread of Corona Virus Disease 2019 and National Economic Recovery.
- l) Visit Visa on Arrival for Tourism may also be granted to foreigners holding Diplomatic Passports or Service Passports who are not citizens of a Country, Governments of Special Administrative Region of a Country, and Certain Entities as the Subject of the Visit Visa-Free Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) in the event that there is no Representative of the Republic of Indonesia in their country/place of residence or for sudden/urgent activities, by examining the following requirements:
- (1) Diplomatic Passport or Service Passport that is valid and still effective for at least 6 (six) months,
 - (2) Return ticket or transit ticket to carry out the journey to another country,
 - (3) Letter of request from the Ministry/Institution/Agency of the Republic of Indonesia,
 - (4) Letter of approval from the Director General of Immigration, and
 - (5) Proof of payment of PNBP for visit visa on arrival.

- m) The Request for a letter of approval from the Director General of Immigration as referred to in letter l) number (4) is submitted by the head of the Ministry/Institution/Agency of the Republic of Indonesia to the Director General of Immigration Attn. Director of Immigration Traffic by attaching:
 - (1) A letter of request from the Ministry/Institution/Agency of the Republic of Indonesia containing the data of foreigners and the reason for the submission,
 - (2) Diplomatic Passport or Service Passport that is valid and still effective for at least 6 (six) months, and
 - (3) Return ticket or transit ticket to carry out the journey to another country,
- n) Foreigners holding a Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) and a Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) cannot apply for a New Stay Permit through a Visa application;
- o) Foreigners holding a Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) and a Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) may leave the territory of Indonesia through all Immigration Checkpoints;
- p) The tariff applicable to the Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) is the Visit Visa on Arrival rate as referred to in the Appendix to Government Regulation Number 28 of 2019, which is in the amount of IDR 500,000,-;
- q) Perform data reconciliation between PNPB payments, the use of Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) stickers, with immigration crossings on a daily, weekly and monthly basis;
- 2) Periodically report the granting of the Visit Visa-Free Specifically for Tourism (*Bebas Visa Kunjungan Khusus Wisata*) and Visit Visa on Arrival Specifically for Tourism (*Visa Kunjungan Saat Kedatangan Khusus Wisata*) to the Head of Immigration Division.

6. Closing

- a. With the enactment of this Circular Letter, the Circular Letter of the Director General of Immigration Number IMI-0650.GR.01.01 of 2022 regarding the Ease of Immigration in Order to Support Sustainable Tourism during The Corona Virus Disease 2019 Pandemic is revoked and declared as invalid;
- b. This Circular Letter shall come into force on September 15, 2022 on 00.00 Western Indonesian Time (WIB) and shall be further evaluated.
