**SECOND ADDENDUM TO CIRCULAR LETTER
NUMBER 25 OF 2022**

REGARDING

**HEALTH PROTOCOLS FOR INTERNATIONAL TRAVELS DURING THE CORONA VIRUS
DISEASE 2019 (COVID-19) PANDEMIC**

A. Background

1. Whereas to follow-up the development of the SARS-CoV 2 virus situation management and other health issues during the Covid-19 pandemic it is thus necessary to implement adjustments for the mechanism of international travels; and
2. Whereas based on the considerations as stated in number 1, it is necessary to determine the Second Addendum to the Circular Letter of Corona Virus Disease (Covid-19) Handling Task Force regarding Health Protocols for International Travels during the Corona Virus Disease 2019 (Covid-19) Pandemic.

B. Purpose and Objective

The purpose of this Second Addendum to Circular Letter is to adjust change in the use of the PeduliLindungi application to the SATUSEHAT application. The objective of this Second Addendum to the Circular Letter is to support medical transformation and to prevent the increase of the transmission of the Corona Virus Disease 2019 (Covid-19).

- I. Amending the prerequisite of documents of departure of PPLN from Indonesia on number 1 as follows:
 1. WNI PPLN aged 18 years and older departing overseas from Indonesia shall present their third dose vaccine (booster) vaccine card/certificate (physically or digitally) through the SATUSEHAT application.

J. Document Prerequisites of Arrival of PPLN to Indonesia

- I. Amending the prerequisite of documents of departure of PPLN to Indonesia on number 1 as follows:
 1. PPLN is required to use SATUSEHAT application by first downloading the application before departure.
